Sprint cars bring excitement to Elmwood

The United Rebel Sprint Series 305 Sprint Cars invaded Elmwood Park Speedway in Norton, KS, on Saturday evening, July 30, for the first of two nights of auto racing during the Norton County Fair.

Luke Cranston of Plains took advantage of his pole starting position to lead all 25 laps en-route to a trip to victory lane. Brian Herbert chased Cranston early on but Cranston used lapped traffic to his advantage to pull away from his competitors. The lone caution waved on lap 10 when Howard Van Dyke looped his car in turn 4, but Cranston pulled away on the restart and never looked back. Herbert had to settle for second, followed by the three heat race winners Jeff Radcliffe, Zach Blurton and Darren Bowman.

The IMCA Stock Car feature went 15 caution free laps, and 'The Taz Man' Tyler Hahn of Stockton led from green to checkered. Heat one winner Jay Hachmeister chased Hahn but had to settle for the runner-up spot, followed by Pat Bedore, Jason Davis and Dustin McClurg. Heat two winner Bob Rutherford ran sixth.

Second heat victor Tanner Portenier took the early lead in the IMCA Sport Mod main event. Portenier led the field to the halfway mark of the 15-lap race when the caution waved for a single car spin. When

the green flag replaced the vellow, point leader Brian Conness of WaKeeney passed Portenier to take the point. A late race caution gave the field a chance, but Conness held on for his third win of the season at Norton. Second running Portenier spun in turn 4 on the last lap, but track officials deemed third running Ben Hobbs made contact on Portenier and gave Portenier his second place finish. Hobbs then was third, followed by Tyler Watts and Kenny Schmidt. Frank McClurg won the other heat race.

Hometown driver Kelly Karnopp remained undefeated at the half-mile oval. Heat race winner Karnopp drove around leader Kirk Karst on lap 5 of the 12-lap IMCA Hobby Stock feature for a trip to the winner's circle, his fourth appearance in four outings this season. Jeromy Wagner, Karst, Anthony Martin and Rick Maynard rounded out the top five.

Beloit's Brian Calhoon was a double winner. Calhoon won the IMCA Modified heat race, then took top honors in the feature. Tim Watts and Jason Davis ran second and third.

Norton Auto Supply added \$100 purse money to the winner of the stock car and sprint car features.

All five divisions returned for the second night of fair races on Sunday, July 31.

"A lot of different people look at the rides every year," he explained. "This particular piece of equipment was professionally inspected in 2008 and again in 2010. The ride wasn't inspected prior to use this year because an inspector wasn't available to visit us before the fair." Eveleigh reported that Norton belongs to a network of homeowned carnivals and together, the groups hire inspectors for the home-owned rides. The inspections are subject to inspector availability and may not be inspected every year. About 10 years, ago, a similar situation occurred on the ride known as "The Octopus" where a cart fell from a support beam, but because of the low profile to the ground, the cart fell only a few feet and no injuries were
