Cause of fire undetermined

An apartment on the east side of Norton has suffered significant smoke damage after a fire broke out in the building Tuesday afternoon.

Norton Fire Chief Mitch Jones reported that fire crews were called to the scene at 405 E. Holme Street just before 2:45 p.m. Tuesday after a fire was reported in a small apartment building at that address.

Upon arrival, fire crews found that the second floor of the structure was burning, but Jones said the smoke and flames were contained primarily to the main living area of the upper floor.

The 16 firefighters responding to the call were able to contain and extinguish the blaze in a very short time.

"We got a good knockdown

on the blaze and we were able to contain it mostly to one room," Jones said. "The smoke and fire damage were pretty much contained only to the second floor."

Fire crews were on the scene for just under two hours, but were called back at about 9 p.m. Tuesday evening when the fire reignited in the building. Firefighters spent about an hour working through the building's attic to locate and extinguish any smoldering spots.

Jones said the cause of the fire was undetermined Thursday afternoon and a state fire marshal may be called in later to determine a cause.

The Norton Fire Department, Norton Police Department, Norton County Sheriff's officers and Norton County EMS responded to the fire.

Former police officer released on diversion

After months of court proceedings and negotiations, a former Norton police officer accused of sexually assaulting two women was freed, with stipulations, Wednesday after a motions hearing in Norton County court.

Ryan L. Zweygardt was released on a two-year diversion just one week before he was scheduled to go to trial on charges of rape and aggravated battery.

Zweygardt was originally charged on April 21 with two counts of rape, one count of aggravated criminal sodomy and one count of aggravated battery after two women accused him of sexually assaulting them in two separate incidents. The charge of aggravated battery was later dropped.

Since his April 21 arrest, Zweygardt has been held in the Graham County jail and was slated to go to trial next Thursday.

Norton County prosecutor Doug Sebelius reported, however, that he and Zweygardt's attorney, Dan Walter, reached an agreement that will defer a possible trial and keep Zweygardt out of jail for two years if he fulfills stipulations set forth by the arrangement.

"Mr. Walter and I reached an agreement to place the defendant on a two-year diversion agreement," Sebelius said.

"If he has to go to trial, it will be for charges other than rape."

Essentially, Sebelius said, if Zweygardt is a model citizen for the next two years and fulfills requirements set forth by the court, all charges will be dropped after two years.

As part of the diversion agreement, Zweygardt is released from custody and will be required to reside within the state of Kansas for the next two years. He is also required to undergo therapy for anger and aggression management and work with Norton County Court Services to fulfill the provisions. He is also barred from contact or communication in any manner with the alleged assault victims and is prohibited from seeking further employment as a law enforcement officer.

While Sebelius and Walter reached an agreement before the case went to trial, the prosecutor admitted that the outcome wasn't exactly what he had hoped.

"You can say you're never totally satisfied with the outcome, but I think this solution best serves the interest of justice," Sebelius said. "The defendant has the opportunity to better himself without suffering the full repercussions of what could come from taking the case to trial."

Dan Walter, Zweygardt's attorney, was not available to comment on the case Wednesday or Thursday.

No injuries reported in Wednesday crash at 2nd, Highway 36

Three drivers avoided injury Wednesday afternoon when their vehicles collided in a minor accident at the intersection of Second Street and Highway 36.

Norton Police Chief Pat Morel reported Thursday that about 3:30 p.m. Wednesday, Joseph Annon was operating a Ford Ranger westbound on Highway 36, attempting to turn south onto Second Street. At the same time, Heidi Lane-Davis was operating a Ford Taurus eastbound on Highway 36, also attempting to turn south on Second Street. Annon didn't see Lane-Davis trying to turn at the same time and the vehicles collided. The impact pushed the Taurus
