cbell@nwkansas.com After a collision on Highway 36 late Thursday morning, an Almena man has been taken to the Norton County Hospital for treatment of injuries sustained in the crash.

According to information from the Kansas Highway Patrol, Steven L. Brown, 20, of Almena was driving a 1999 Dodge pickup truck at about 11:24 a.m., attempting to make a left turn from a private driveway onto Highway 36 on the east edge of Norton.

Brown pulled onto the highway in front of a semi truck and trailer driven by Dennis Reicks, 24, of Kearney, Neb., who was eastbound on Highway 36. The semi struck the pickup on the driver side and both vehicles came to rest in the north ditch of the highway.

The impact of the crash caused the bed to be completely ripped from the cab of the pickup and dented the rear driver side portion of the cab. The semi truck sustained damage to the

front left fender area.

Brown was injured in the crash and was transported by Norton County EMS to the Norton County hospital for treatment. Reicks refused treatment at the scene. Both drivers were wearing safety restraints at the time of the crash.

# State to renovate portion of Highway 36

Beginning next week, the Kansas Department of Transportation will begin work to reconstruct a section of US-36 Highway in Norton County.

Starting at the east city limits of Norton, and continuing east approximately 4.5 miles to the US-36/K-383 junction, workers will rebuild the roadway on existing alignment.

Work will begin in late February to extend or replace the drainage structures along this route.

Beginning on approximately March

Flaggers and a pilot car operation will guide one-lane traffic through the early autumn work zone during daylight hours. Delays of 15 minutes or less will be expected throughout the construction time frame. Commuters are asked to plan their travels accordingly, especially those commuting to/from work, during all phases of the construction.

Please use caution, pay attention to the work zone signs, and respect workers when driving through any road construction zone. Slow down and "Give 'Em A Break."

The department awarded the construction contract - totaling \$4,945,124 - to Venture Corporation, of Great Bend.

Subcontractors on the project include Sporer Land Development, earthwork; All Road Barricades, traffic control: Merz Bros. Construction, seeding/erosion control; Ballou Pavement Solutions, cold recycle; PCI Roads, LLC, safety barrier; Survey's, Inc., construc-

tion staking; Smoky Valley Electric, traffic signals; Reece Construction Co, concrete; J&J Contractors, concrete; Fulsom Brothers, Inc., guardrail and signing; Industrial Pipelines South Central, Inc., pre-watering.

The pavement reconstruction project is funded by T-WORKS, the transportation program passed by the Kansas Legislature in May of 2010.

Weather permitting the construction work will be completed by next January.

#### Feb. 29 is deadline for license renewal

Feb. 29 is the deadline for the renewal of heavy truck and trailer tags and all persons whose last names begin with "A." Remember to include current proof of insurance for all vehicle. Drivers license renewals can be done Tuesday through Friday from 8 a.m. to 4 p.m. Anyone renewing will need have current drivers license, social security card or something with the number on it and a current utility bill or current bank statement with proof of address.

12, workers will replace the US-36 drainage structure located just east of the intersection of US-36/K-67 (roadway to the Norton Correction Facility).

During the bridge work, one-lane traffic will be controlled with a traffic signal.

Continuing through the summer months, earthwork will be performed to provide flatter shoulders.

This fall, the 4.5 miles of roadway will be reconstructed utilizing a cold recycle operation, followed by a fiveinch overlay of new asphalt material.
