County agrees to establish cemetery district

After a public hearing on the matter, the Norton County Commissioners approved a resolution Monday morning to establish a cemetery district in the West Union portion of the county. The district will cover the Densmore, Catholic and Archer cemeteries.

A small group of citizens gathered at the public hearing with the commissioners to discuss the creation of the district and discuss options for caring for those cemeteries. Currently, the cemeteries are not in a district and are under no established procedures for care and maintenance. The establishment of a district, however, will allow

for the creation of a five-member board of directors to manage the cemeteries.

According to the resolution, the township trustee of Solomon Township has 30 days to "call a meeting of all the qualified electors of the newly created cemetery district for the purpose of organizing the cemetery district into an association and for the election of five

directors who shall have the authority to provide for the care and maintenance of the district cemeteries...(and) reside within Norton County."

Though county leaders could levy up to \$6,000 per year to cover the cost of caring for the cemeteries, no decisions were made Monday on how much money would be needed.

to the Norton County Clerk's Office (Courthouse, 2nd floor) with a photo identification to fill out a voter registration form prior to Tuesday, March 13. Norton County Clerk Robert Wyatt reports that the identification can be drivers license, state issued identification card, government-issued identification or college identification. Regardless of the type, the photo identification must bear a current photo and name of the person registering.

The polling place for the Lenora City Council election will be the Lenora Community Building.

After owning the business for nearly 17 years, Ron and Vicki Fisher announced recently that the Brooks Motel is now under new ownership.

Late last year, the Fishers sold the business to the Vasant "Victor" Bhakta family, who took over operation in late December.

Sandy Bhakta, who is operating the hotel with his parents and brother, reported this week that the family came from Arizona, where they had been managing a chain of Motel 8 lodging

facilities. Since taking over ownership of the Brooks Motel, Bhakta said, the family has been working on some upgrades at the business, including adding microwave/refrigerator units to the rooms and adding new television sets to the rooms. The family is also planning future upgrades of adding a new roof to the building.

With the new ownership, Bhakta said, the name of the business will not change and it will still be known as the Brooks Motel.
