BB Gun team finishes second at state

The Norton County Rotary BB Gun Team qualified for the National Championships for the second time this season with a runner-up finish in the American Legion State Shoot on Saturday in Alma, Ks.

Norton will compete once again in the Daisy National BB Gun Championships to be held the first of July in Rogers, Ark.

The young marksmen from the Norton Yellow team had already qualified for the national competition during the State 4-H Shoot on April 14, which was also held in Alma.

On Saturday, the Norton team recorded a total score of 2295, which includes shooting from the prone, standing, sitting and keeling positions as well as the written test on gun safety.

They were just 19 points behind the champion Wyandotte Gold team which had a total score of 2314.

Finishing third was Derby with a 2275 score, followed by Wyandotte Green, 2234; Bullmasters Red, 2231; Flint Hills Jr. Shooters No.1, 2221; Riley/Potawatomie Purple, 2208; Bullmasters Black, 2199; Johnson County, 2182; Sedgwick Purple, 2182 to round out the top ten teams.

The Norton Blue team placed 14th with a 2029 score.

Members of the Norton Yellow team were the same as in the two previous shoots, the Kansas Rifle Association and Kansas 4-H shoots. They were James Berry, Erin Archer, Colton Mulder, Stacie Elliott and Dylan Goss. Assistant coach of the Yellow team to head coach Cameron Archer was Cris Mulder.

Members of the Blue team were Nick Davis, Miles Harrington, Tia Paxton, Ryan Lively and Evan Chambers. The two coaches for the Blue team were Tedd Hull and Jeff Elliott.

"We had a wonderful day and we shot very well," said coach Archer. "A little more hard work and our shooting at the national will be even better.

"Our two experienced shooters, James and Erin, continued to shoot well and our younger shooters also shot well. I'm very proud of all of them. They stepped up and did what they had to do.

"I explained to them after the shoot

that if each had shot just one point better on each target they would have easily won the championship. "

James Berry was the top shooter out of the 105 marksmen from 8 to 14 years of age entered in the shoot. He shot a 385 aggregate and his 94 on the written test was good enough to rank him No.1 overall. James was also top shooter from the standing position with a 96 and was runner-up from the prone with a 98.

Norton's Colton Mulder shot a 97 in prone which was good enough for third best of all individuals and Erin Archer also shot a 97 in prone to place fourth individually.

Colton Mulder placed fifth individually among all entrants in combined shooting and written test scores, Erin

Archer ranked sixth best and Stacie Elliott was ninth best.

Both Norton teams did very well on the written test. The Yellow team had a 476 on the written test and the Blue team was right behind them with an excellent 470.

Stacie Elliott recorded a perfect 100 on the written test.

Council approves first reading of ordinance

The Norton City Council approved Wednesday evening the first reading of an ordinance to establish a Public Building Commission for the city as the council prepares to propose a sales tax increase to construct a new public swimming pool.

According to ordinance #1620, the Public Building Commission will consist of seven members to include the six city council members and the city

mayor with terms on the commission to coincide with city council terms of office.

According to Rick Ensz, the city's bond underwriter for a potential pool project, the purpose of the public building commission is so that the city can issue bonds for the project without going against the city's statutory debt limit. Because the commission cannot issue bonds or debt of any kind, the commission leases property to the city, which can issue bonds.

Though the first reading was approved Wednesday evening, Ensz and the council discussed the future of the commission and whether or not the commission will stand even if the city doesn't move forward with the pool project. According to Ensz, the commission will remain in effect until the city decides to deactivate the group

and if the city decides to issue bonds in the future while the commission still stands, the city won't have to go through the steps to form the commission again.

The ordinance will require two more readings by the city council and legal publication before it will become official.

Following some disagreement over whether a project had been completed to county regulations, the Norton County Road and Bridge Department is reminding county citizens of the steps necessary to trench across county roads.

According to a resolution from the county commissioners in 1999, anyone "using a county road to bury, lay or install any type of pipeline, cable or conduit with the county road right-of-way shall pay a permit application fee in accordance to (the fee) schedule."

The fee schedule is as follows:

-All pipelines installed in regularly maintained roads: \$250 per crossing if trenched and \$50 per crossing, if bored
-All pipelines or cables installed in

low maintenance roads: \$50 per crossing, if trenched or bored

Anyone wishing to trench or bore across a county road is required to obtain a permit application from the county's road and bridge department. The permit application requires information about what the proposed project will entail and when the project is expected to be complete.

After the project is complete, a representative of the road and bridge department will inspect the site to make sure the road is returned to its previous condition before the project was begun.
