Norton golf team wraps up successful season

nortontelegram@nwkansas.com Coach David Stover's Norton Community High School golf team, led by a strong junior class, had a successful 2012 season and is looking forward to an even better one next year.

Taylor Meder was the only senior letterman. Junior lettermen were Chris Fisher, Treven Rossi, John Risewick, Eli Bozarth, Andrew Ellis and Cassius Dole. There were no sophomore lettermen.

Norton opened the season on Tuesday, April 3 with a solid runner-up placing in the Redmen Invitational in Smith Center. Phillipsburg won the championship with a 339 but Norton shot a close 369. Ellis was low man for Norton with a 44/46-90. He was sixth medalist. It was his first career varsity medal.

On Tuesday, April 10, Norton traveled to compete in the Goodland Invitational. The Blue Jays shot a season low round but placed sixth, just four points out of third, in a tough tournament. Bozarth was low man for Norton with a 40/48-88, just missing medalist honors by four strokes.

The Norton junior varsity competed in the JV Invitational

at Hill City on Friday, April 13 and placed fourth. Bainter shot a 44, which ranked him sixth among medalists.

On Tuesday, April 17, the Norton junior varsity golfers played in the Goodland JV Invitational. No team scores were kept but the Blue Jays ended with five of the top six medalists. Dole was low medalist with a 44, followed by junior Javen Colip, runner-up medalist, 45; Bainter, third medalist, 45; Meder, fifth medalist, 47 and freshman Chance Uehlin, sixth medalist, 47.

The Norton Invitational Golf Tournament was held on Thursday, April 19 at the Prairie Dog Recreation Association course south of Norton and the Blue Jays played well again, finishing third behind outstanding Phillipsburg and Colby teams. The Panthers won the championship with a 322, followed by Colby, 357 and Norton, 364. Fisher was No.1 golfer for Norton with a 42-40/82, good enough for fifth medalist.

"We continue to see improvement," said coach Stover. "There were many bright spots. We need to continue to improve consistency. We must put together good 18-hole rounds

instead of one good nine-hole

On Tuesday, April 24, the Norton junior varsity golfers had their best outing of the season when they played in the Smith Center JV Invitational. The Blue Jays edged Phillipsburg for the title, 189-190. Norton sophomore Garret Otter was low man for the Jays with a 46, which earned him runner-up medalist. Junior Jordan Hartwell shot a 47 to tie for third medalist. Colip and Dole shot 48s to tie for seventh medalist.

The Norton varsity returned to action on Thursday, April 26 in the initial I-70 Invitational, which was scheduled to be played in Ellis and WaKeeney but was only played in Wa-Keeney. The Blue Jay varsity played their best of the season and finished third. Trego won with a 326, Ellis shot a 328 and Norton a 337. Fisher was low man for Norton with a 39-41/80, which tied him for fourth medalist. Ellis was next lowest with a 40-45/85 and Risewick shot a 43-43/86. All three scores were career low tournament tallies.

"Today's team score was a 23-stroke improvement over our previous season low!" said coach Stover.

On Monday, April 30, Norton traveled to Hays to play in the Thomas More Prep Tournament at Smoky Hill Golf Course. It is not usually a good tournament for Norton and once again it was not. The Blue Jays tied for eighth as a team. Fisher was low man for Norton with a 47-

The next day, Tuesday, May 1, was a good one for the Norton golf program. The Blue Jays hosted the Norton JV Invitational and won the championship! Norton shot a 176 to easily outdistance runner-up Phillipsburg, who shot a 205. Junior Dustan Daniels shot a 41 to win No.1 medalist honors! Colip carded a 45 for fourth medalist, Dole shot a 45 for fifth medalist, Otter's 45 earned him sixth medalist honors and Bainter was seventh medalist with a 46.

"Everyone did a great job," said coach Stover. "We were led by Daniels' first individual tournament title and five of the top seven medalists."

On Thursday, May 3, Norton competed in the Colby Invitational varsity tournament. The Blue Javs tied for fourth as a team. Ellis and Bozarth were low scorers for Norton. Ellis shot a 45-45/90 and Bozarth carded a 46-44/90.

Also on Thursday, May 3, Norton junior varsity golfers competed in the Trego JV Invitational in WaKeeney. The Blue Jays placed sixth. Uehlin tied for 11th medalist with a 48/50-

The Norton junior varsity golfers gained valuable experience on Friday, May 4 when they competed in the Hill City Invitational for varsity golfers. Hartwell was low man for Norton with a 49-44/93. "Our junior varsity completed a very successful season," said coach Stover.

The Norton varsity golfers turned in an excellent performance in the Mel Schremmer Invitational Tournament in Phillipsburg on Monday, May 7. The Blue Jays placed fourth in four-man play and tied for sixth in the two-man division.

Playing for Norton's fourman team and their scores were: Fisher, 43-41/84; Ellis, 46-39/85; Risewick, 44-41/85 and Bozarth, 46/42/88.

The annual Mid-Continent League Golf Tournament was held on Thursday, May 10 in Phillipsburg. Norton placed fifth out of nine teams. Risewick was low scorer for the

Blue Jays' four-man with a 43-39/82, which was a career low. Shooting career lows for Norton's two-man team were Otter, 48-40/88 and Rossi 48/42/90.

The incredibly tough Class 3A Regional Golf Tournament was held in Lakin on Monday, May 14. The top two teams were Goodland, first and Phillipsburg, second, and both qualified for the state tournament.

In the opener, Norton trailed 13-4 after four innings but rallied to make the final 13-12. Plainville pitching took over in the nightcap as the Cardinals won 15-0.

First game Plainville led 1-0 after the first inning but Norton took a 2-1 advantage in the top of the second when Jacob Green doubled and Trenton Wright singled him home and also scored. Layton Miller, Will Ellis and Ryan Johnson all walked but were unable to score.

Plainville scored four runs in the bottom of the third to make

it 5-2. Norton narrowed the lead to 5-4 with two runs in the top of the fourth. Green hit a solo home run and Wright and Miller both doubled, scoring Wright.

The Cardinals responded with an eight-run bottom of the fourth to expand their lead to 13-4. They had just three hits in the inning but took advantage of Norton errors and some walks.

Johnson walked to start the top of the sixth and Kinderknecht and Cole both singled. Green

blasted his second home run of the game and Norton trailed by just 13-12 but the game ended with the Blue Jays coming up just one run short.

Next action


Norton will be on the road again on Thursday when they play at Smith Center.
