

# Records available through state

In preparing students for school enrollment, the Kansas Department of Health and Environment provides information related to birth certificates and immunizations.

## Birth Certificates

The Bureau of Epidemiology and Public Health Informatics provides the option to get a birth certificate online at [www.kdheks.gov/vital/birth.html](http://www.kdheks.gov/vital/birth.html). You can obtain your birth certificates in person from the Office of Vital Statistics from 9 a.m. to 4 p.m. Monday through Friday at 1000 SW Jackson Street, Suite 120 in Topeka. There is a \$15 fee for each certified copy of a Kansas birth certificate.

General questions can be answered at (785) 296-1400, from 8 a.m. to 5 p.m. Monday through Friday. The telephone service is automated with a

directory to provide options for accessing recorded information for requesting certified copies, inquiring about the status of previously submitted requests or speaking with a staff member, if other assistance is needed.

## Immunizations

The Bureau of Disease Control and Prevention provides up-to-date immunization information, which includes the latest 2012-2013 School and Child Care Immunization information at [www.kdheks.gov/immunize/schoolInfo.htm](http://www.kdheks.gov/immunize/schoolInfo.htm). This site also provides immunization requirements, school entry requirements, the Medical Exemptions form and the Kansas Certificate of Immunization. # Cost-share available for water supply

The Kansas State Conservation Commission recently approved a plan to work with Kansas livestock producers on a cost-share program targeted at improving existing livestock water supplies. The Kansas Department of Agriculture's Division of Conservation urges livestock producers to focus project applications on restoration of existing ponds, well development, spring development or other water storage projects.

The commission, which is a board of commissioners consisting of five elected and four appointed members, approved the use of \$500,000 of fiscal year 2012 cost-share funding that has been carried forward to provide immediate assistance to livestock producers in drought-

stricken Kansas. Producers will have 45 days to sign-up for the cost-share assistance initiative and will be eligible to receive up to \$2,000 per project and up to \$4,000 per landowner. Projects will be considered and approved on a first-come, first-served basis. The department's Division of Conservation will collect applications submitted by county conservation districts and then process and approve individual contracts.

Pastures that currently have limited or no existing water supplies are the primary targets for this initiative. Livestock producers with existing ponds who are requesting cost-share assistance must meet specific criteria to be eligible. Specifically, dams must be in satisfactory condition or

the landowner must commit to bring the dam to a satisfactory condition and the pond must still be capable of serving a conservation use for stock-water. Cost-share funding can be used for sediment removal; principal spillway replacement; or embankment seeding. The Division of Conservation and the county conservation districts will be flexible with livestock producers to help assure they meet the specific criteria.

Projects related to well development, spring development and new ponds will follow current policy requirements.

# Department of Health and Environment issues pooled stream notice for algae

The Kansas Department of Health and Environment samples recreational bodies of water for cyanobacteria, commonly called blue-green algae, when the agency is alerted to a potential algae bloom.

When harmful algal blooms are present, the department in cooperation with the Kansas Department of Wildlife, Parks and Tourism and other lake managers where appropriate, re-

sponds by informing the public of these conditions. Based upon sampling results and established health risk levels, the following Warnings and Advisories are in place.

When a lake is under an advisory or warning, marinas, lakeside businesses, and park camping facilities remain open for business, although swim beaches will be closed. Park drinking water and showers

are safe and not affected by the algae bloom. Also, it is safe to eat fish caught during a harmful blue-green algae outbreak, as long as consumers clean and rinse the fish with clean, potable water; consume only the fillet portion; and discard all other parts. People should also wash their hands with clean, potable water after handling fish taken from an affected lake.

# Additional land made available for emergency haying/cutting

Kansas Governor Sam Brownback has expressed his administration's appreciation for the U.S. Department of Agriculture's approval of haying on Conservation Reserve Program acres designated as "CP25," which have been ineligible for emergency haying in the past.

In addition to approving emergency grazing on CP25 acres, the department also declared additional Kansas counties as federal disaster areas. Atchison, Brown, Doniphan and Jackson counties were declared as primary disaster areas. Jefferson, Leavenworth, Nemaha, Pottawatomie and Shawnee were named contiguous disaster counties. Agricultural producers in these counties will be eligible for federal disaster assistance programs.
