Huskies are undefeated; strong win at Logan

The Northern Valley High School Huskies traveled to Logan on Friday, Sept. 21 and beat the Trojans in convincing style, 62-12, leaving Northern Valley 4-0 on the season.

The Huskies' ground assault continues to punish defenses and put up big numbers. Against the Trojans, the Huskies rushed for 342 yards on 54 carries.

In the first quarter, junior running back Jordan Baird scored from 20 yards out, 6-0 Huskies.

With 49 seconds remaining in the first quarter, junior quarterback Hunter Chandler bulled into the end zone from the three yard line, 12-0 Huskies.

Logan responded early in the second quarter with a 15 yard touchdown run from freshman JR Reno. The Trojans trailed by only six points but that would change drastically later in the game.

Chandler found the house from 20 yards out and Baird made good on the 2-point conversion, 20-6 Huskies.

Chandler followed up with a 1 vard dive into the end zone and scored the conversion and the Huskies extended their lead to 22 points. One minute and three seconds

later, Baird scored from the three yard line and sophomore running back Phillip Bryant found the end zone on the conversion, 36-6 Huskies.

And with only nine seconds left in the first half, Bryant scored his first touchdown on the night from the 2 yard line the passing game. The line gave in Almena.

In the third quarter, the Huskies found success through the air. Chandler connected with senior receiver Tyson Callaway on a 22 yard touchdown pass. Baird scored the conversion and the lead was 44 points over the

Midway through the third, Trojan junior Brett Pinkerton cut through the Huskies defense on a 15 yard touchdown run, Logan trailed 50-12.

Despite the big lead, the Huskies continued to play hard. Bryant got loose on a 50 yard touchdown run and it was 56-12 Huskies.

At the beginning of the fourth quarter, the 45 point rule was put into effect when Chandler scored from the one yard line, giving the Huskies a 50 point lead, 62-12, ending the game with 11:58 remaining in the fourth quarter.

Huskies head coach Chuck Fessenden was pleased with his team's continuous improvement in several facets of the game.

"This game gave our linemen an opportunity to learn and improve. Logan was blitzing quite a bit on defense. Our linemen did a good job of adjusting and picking up blitzes," said Fessen-

The Huskies' passing game, for the most part, has been ineffective through the first three games but that changed against the Trojans.

Hunter Chandler some time to throw and he threw some nice passes," Fessenden said.

Chandler was four for six passing for 85 yards and one touchdown. Senior receiver Jon Compton had one reception for 16 yards, sophomore receiver Clint Cole's one reception was good for 24 yards, Baird had one reception for 23 yards and Callaway's 22 yard reception went for six.

But the running game is this team's strength. Once again, the trio of Baird, Bryant and Chandler rushed for over 100 yards each. Baird rushed for 117 yards on 23 carries and two touchdowns. Bryant had 116 yards on 15 carries and two touchdowns and Chandler rushed for 108 yards on 16 carries and four touchdowns.

"Our running game was strong once again as we had all three backs go over 100 yards," said Fessenden.

The Huskies leading tacklers were senior Terry Shrader with seven tackles and seven assists, Callaway had eight tackles, five assists and an interception, sophomore Matt Stutsman with six tackles and six assists, Bryant had eight solo tackles and three assists and Chandler had five tackles, six assists and an interception.

"We have a huge district game with St. John's-Beloit for homecoming next week," said coach Fessenden.

The Huskies' homecoming game against St. John's-Beloit will be Friday, Sept. 28 at 7 p.m.


