

# Cross country teams do well at Lakeside Invite

Coach George Rossi's Norton Community High School girls cross country team won the championship and the boys cross country team placed fifth in the very competitive Lakeside Invitational Cross Country Meet on Thursday in Downs.

The Lady Jays were edged by one point for the championship last year by Sacred Heart of Salina and this year Sacred Heart had to be content with second place.

The Norton girls scored 50 points, followed by Sacred Heart, 68; Southeast of Saline, 76; Lincoln, 107; Oberlin, 109; Belleville, 143; Beloit, 143; Pike Valley, 201; Tescott, 226.

There were 76 girls runners in the race.

The boys champion was Southeast of Saline with 79 points, followed by Belleville, 85; Pike Valley, 95; Sacred Heart, 99; Norton, 102; Lincoln, 145; Phillipsburg, 212; Beloit, 217; Minneapolis, 234; Stockton, 249.

There were a total of 105 boys runners.

**GIRLS**

Sophomore Sierra Griffith was first to finish for the Lady Jays with a fourth place in 16:40. She was followed by junior Darcy Bainter, 11th, 17:03; senior Julia Kent, 12th, 17:04; junior Katelyn Englebert, 13th, 17:09 and freshman Molly

Maddy, 16th, 17:34 for Norton's top five team runners.

Also competing for the Norton girls and their place and times were: senior Kamilla Jones, 26th, 18:10; freshman Raenee Patterson, 35th, 18:46.

Freshman Kylie Perez placed fifth in the junior varsity race with a time of 19:37 and senior Steph Hager finished 14th in 22:49.

"Today, our girls were as determined as I have ever seen," said coach Rossi. "The look in their eyes as they ran by told us coaches that they were going to do what they set out to do and that was to win the championship.

"Sierra Griffith ran an outstanding race and beat several girls who had beaten her during this season. Darcy Bainter, Julia Kent and Katelyn Engelbert ran all together and Molly Maddy was right behind, giving us our 1-5 split of just 54 seconds.

"Kamilla Jones ran a faster time by 35 seconds and Raenee Patterson stepped in for Marisa Maddy, who was ill, and ran a great race.

"We knew this would be a good race with Sacred Heart and Southeast of Saline and it was very competitive. Both of those teams have outstanding runners and the Lady Jays did a geat job of staying with them the entire race.

"Although we are extremely happy with our performance today, we have to put it behind us

and focus on this week and the Regional Cross Country this Saturday in Cimarron."

**BOYS**

Sophomore Marc Miller continued to pace the Norton boys as he finished seventh in 18:00. He was followed by freshman Brendon Frack who was 12th in 18:44; followed by junior Alec Hager, 13th, 18:45; sophomore Dalton Vanover, 25th, 19:09 and senior John Renner, 54th, 20:51 to round out the top five team finishers for Norton.

Also running for Norton and their place and times were: senior Ryan Bainter, 71st, 21:32; junior Keith Sander, 73rd, 21:39.

Freshman Weston Erbert placed 14th in the junior varsity race with a clocking of 21:43. He was followed by junior Kailen Kawahara, 19th, 22:35; freshman James King, 21st, 22:46; freshman Skylar Johnson, 26th, 23:11; junior Chris Chambers, 27th, 23:17; sophomore David Smith, 33rd, 23:57.

"Our boys came out today and give it their all, finishing fifth but only missing third place by eight points," said coach Rossi. "That number of points can be made up by any member of the team.

"Marc Miller, Brendon Frack, Alec Hager and Dalton Vanover were able to medal. Dalton ran the last mile after another runner stepped on the back of his shoe and it fell off. Dalton's foot was covered in stickers at the end of the race but he

did not let it slow him down. That was just a great thing to see.

"John Renner and Ryan Bainter also ran better today. Even though we finished fifth, I was very pleased with how our guys came out and competed. We must continue to keep moving forward to this week. It will be tough in the Regional in Cimarron but these guys can do it."

**Next action**

Norton will next compete in the Class 3A Regional Cross Country Meet this Saturday at the golf course in Cimarron.

In addition to Norton and Cimarron, teams will compete from Anthony-Harper-Chaparral, Cheney, Garden Plain, Kingman, Thomas More Prep-Marian of Hays, Hoisington, Holcomb, Southwestern Heights, Lakin, Phillipsburg, Russell and Scott City.

The girls race will begin at 1 p.m. and the boys race at 1:30 p.m.

The three top teams from each regional meet will qualify for the State Meet in Lawrence. The top ten runners medal and qualify for the State Meet.

The top five individuals from non-qualifying teams will also qualify for the State Meet if not in the top ten.
