### Cold weather rule starts Nov. 1

"The Cold Weather Rule helps to ensure that Kansans can be warm in their home this winter. Consumers are encouraged to take steps to prepare for colder temperatures this winter," said KCC Chairman Mark Sievers.

The Cold Weather Rule prohibits utility companies from disconnecting a customer's natural gas or electric service during periods of extreme cold. The Rule requires utility companies to offer a 12-month payment plan to allow consumers to maintain or re-establish utility service.

Disconnection Conditions:

Utility companies may not initiate disconnection until temperatures are forecast to be above 35 degrees for the next 48

Utility companies must contact the customer by phone or in-person 24 hours before disconnecting service.

Utility companies are prohibited from disconnecting a customer's service when temperatures are forecast to be at or below 35 degrees over the next 24 hours.

The KCC wants Kansans to have the electric and gas service needed to keep their homes warm during the winter months. The KCC also recognizes the customer's responsibility to make arrangements to pay for that service. The Cold Weather Rule was designed in 1983 to ensure that both goals are met.

Payment Plan conditions to maintain or restore service:

Customers must contact their utility company and inform them that they cannot pay their bill in full.

Customers must agree to pay 1/12th of the total amount owed, 1/12th of the current bill, the full

amount of any disconnection or reconnection fee, plus any applicable deposit to the utility.

Customers must agree to pay the remaining balance in equal payments over the next 11 months, in addition to their current monthly bill.

The Cold Weather Rule applies only to residential customers of electric and natural gas utility companies under the KCC's jurisdiction. For a complete list of utilities regulated by the KCC visit: kcc.ks.gov/pi/jurisdictional\_utilities.htm.

## 50 schools will compete in math relays

The 34th annual Kansas High School Math Relays at Fort Hays State University will be from 9:30 a.m. to 12:30 p.m. Thursday, Nov. 8, in the Memorial Union.

Students will compete against each other in a series of six tests: algebra, geometry, number sense, applications, trigonometry and calculations with calculators.

The Department of Mathematics and Computer Sciences predicts that 500 to 600 students from about 50 schools will compete.

"Individuals and teams will be given 20 minutes to complete each test," said Dr. Bill Weber, assistant professor of mathematics and computer

science. "Students can get into teams of three to work as a relay team. One student will start, then one-third of the way through the second student will take over, then the final student." At the end, awards will be presented to the top

three places in the individual and team categories for each grade level and in each subject. The top three schools overall will also get awards based on the total points they earn in their Kansas State High School Activities Association classification. Divisions are 1A; 2A to 3A; and 4A to 6A.
