Health Department update Up in smoke

The Norton County Health Department will be receiving a new used 2012 Chevy Impala.

Department head Gina Frack brought the county commissioners two bids for vehicles during the Monday meeting.

Mrs. Frack said that she wanted a simple car without anything that would make it stand out as a health department vehicle and, when she asked for bids, she looked for a car that the dealers could sell if the county didn't take that one.

She gave the commissioners two bids for the vehicle. She said she had asked all three used car dealers in town - Walter, Engel's and Jacobs - for bids. Both Walter and Engel's submitted bids, she said.

The winning bid was for a vehicle with 20,600 miles from Engel's for \$17,500.

Mrs. Frack also discussed how the Emergency Medical Services could share information with other health agencies,

such as the hospital, in order to better serve their patients. She told the commissioners

that she is on a governor's steering committee with 29 other health-related agencies from across the state. She said from this committee she has learned that there will be changes in how the state handles health agencies and patients populations. She said she doesn't know what the changes will be, but they are coming.

"I'll be interested to to see what changes come," she said. "No matter what, changes will come by Jan.1. Although some people hope it won't happen."

Commissioner John Miller said that he was glad she is on the committee so that Northwest Kansas doesn't get forgotten in the process.

"We don't want people out here in the frontier counties, as they call us, to drop through the cracks," he said.

In other business, the commissioners:

• Agreed to set up a safety meeting before the end of the year to make sure the county gets the best rates on its insurance

• Decided to continue the burn ban in the county. Commissioner John Miller noted that nothing has changed. It's still dry. In fact, he said, he was surprised that there were no fires last week when the wind was blowing so hard.

• Heard a report from Mr. Miller on the landfill. He said that the county still has a bad plastic problem with stuff blowing all over. He said he took photos of the problem. New screens will have to be put up along the construction and demolition pit.

• Learned that money will have to be moved around because reimbursements for the sheriff's office were put in economic development's capital development fund.

• Left the meeting early to attend the funeral of Lyman Rowh.

Dr. R.A. Peterson, who defeated commissioner Carolyn Applegate, attended the meeting.

Ms. Smith said that she is just asking the departments to get the information needed together. Then she sits down with them and can get their people put into the computer in just a few minutes. gested that the sheriff's office would be better suited for the task and Ms. Smith said she had someone in mind who might be able to help.

She also told the commissioners that she had only one hand-held radio and no spares. She said that the radios are expensive but that she has some money left in her budget this vear because she had planned to buy some equipment.

After discussion of where radios are most needed and whether it would be better to get the new narrow-band radios or some used ones that other counties are dumping on the market as they get newer models, the commissioners suggested that she work with the sheriff's office. The commissioners asked her to get two bids on anything she found, if that was possible but Mr. Miller said that might not be feasible if she got used equipment.

PUBLIC NOTICE PRAIRIE DOG CREEK WTAP SIGN-UP OPEN

The Kansas Department of Agriculture will b accepting applications for the Water Right Transition Assistance Program (WTAP) from October 1 to lovember 15.

WTAP is a voluntary, incentive-based program designed to help restore aquifers and streams in critical areas by retiring water rights. The Prairie Dog Creek Basin is significant in requirements to maintair compliance in the Republican River Compact with the State of Nebraska. The "high priority" areas of this basin in Phillips, Norton, Decatur, Sheridan and Thomas counties have been determined to be in need of stream restoration and aquifer recovery and are now closed to further water appropriations.

Applicants who are selected for WTAP grants ar ompensated by the department's Division of Conservation in exchange for the per anent retirement of water rights on irrigated land.
