Hospital Administrator Rich Miller, Chief Financial Officer Ryan Stover and board members Steve Berry, Warren White and Reva Benien visited with the Norton County commissioners during the weekly commission meeting on Monday.

Mr. Stover presented the commissioners with a copy of the hospital's annual audit, which is done by BKD, a Wichita accounting firm.

The report done on the hospital's year, which ended

The auditors pointed out that accountability is hard to spread out, as it should be, because the hospital operates with a small staff.

The hospital had a net patient revenue of \$10.2 million last year but also had expenses of \$10.7 million, 60 percent of which went for salary and benefits. Other operating income was \$263,000.

The doctor's clinic at the hospital accounted for an increase in salaries and expenses this year, he said. the hospital made a little money.

In 2013, the hospital is facing several issues, he said.

Medicare reimbursement may be cut by 1 percent for a \$41,000 loss and another 2 percent of Medicare money could be lost if new rules are enacted, and that will account for another \$82,000.

In addition, Kansas Medicaid has gone to a managed care system with three insurance companies in charge. The state is expecting to save \$1 billion over 10 years, Mr.

er agreed that the problem would be a big one noting that the emergency medical service had had a similar problem and lost a lot of money because it didn't have the extra person just to deal with the paperwork.

The state has given the medical providers a year, Mr. Stover said. But that isn't enough. It looks like more people will be added to Medicaid, he said, and the reimbursement will drop. The hospital may have to add another employee just

perwork for everyone.

The hospital will also need to start using an international classification of disease, he said. This is already being used in Europe and is a good thing but there are 70,000 codes and the doctors and coders will have to document everything. It's going to be tough, he said.

Commissioner Miller noted that the hospital would need more staff just for the coding.

"The hospital board and administration will have a huge challenge," he said.

Hospital administrator Miller said that newer doctors will be able to adapt to the changes easier but the whole em-

## Norton woman faces jury trial in April of 2013

Samantha Rojas of Norton appeared before the district court at the Nov. 19 motion day for her arraignment hearing and stood mute. The plaintiff in this case is Stull and Associates of McCook, Nebraska. Rojas has been charged with two counts of forgery, both level 8 non person felonies and five counts of theft, all five Class A nonperson misdemeanors. All charges occurred due to multiple incidents on different dates. Rojas is currently out of jail on a \$10,000 bond and is scheduled to have a pretrial conference with the court on April 8, 2013. After this appearance, the case will go to a jury trial. The trial date is set for April 25, 2013 at 9 a.m. Rojas is being represented by the court appointed council of Mark Whitney.
