#### Tag renewals are due by Wednesday

July 31 is the last day to purchase "J", "K", or "L" tags from the Norton County Treasurer in the Courthouse. Bring current proof of insurance for all vehicles. You can now get your Kansas Parks Passports when renewing your tags for \$15.50 per vehicle. For trailers, include current insurance for the vehicle that will pull the trailer. Office staff will verify VIN number, policy number and current expiration date. Office hours are Monday through Friday 8 a.m. to 4:30 p.m.

Drivers' license renewals can be processed Tuesdays through Friday from 8 a.m. to 4 p.m. You need to have your driver's license and a current utility bill or current bank statement with your name and address for proof of residency. CDL renewals must be done at Phillipsburg, Hays or Colby.

# Norton City Council looks at improvement

Scott Sproul gave his semi-annual report at the Norton City Council meeting on Wednesday, July 17.

Sproul said he has been gathering data for the Downtown Commercial Rehabilitation project and the grant application will be submitted in the near future. Also, the Downtown Beautification Committee and Downtown Development Committee are working with the City to complete the pod project.

He reported work had started on the Ryan Addition and Jerol with Penco Engineering is certifying the sewer as it

is being installed. Economic Development is working on infrastructure improvements for a couple of businesses and a downtown market study for rebuilding the downtown area. It will include information on shopping trends, business needs, and a strategic plan on how to attract people to the downtown area. Funding sources for the geometric improvement project are also being examined, to help get matching funds for the city to move the water line for

The Council also held a public hearing for the purpose of considering a specific project application under the 2014 CDBG Downtown Commercial

Rehabilitation program, to rehabilitate Administration Agreement with Northdation, brick and stucco, construction of a new roof system and removal and replacement of 15-20 linear feet along the north and east side of the building for stabilization and support. The estimated total project cost is \$250,000 with the grant request of \$187,500. The sub-recipient, Mark Whitney, would provide matching funds in the amount of \$62,500. The City would have no out of pocket expenses for this project.

### Road and Bridge Department needs a way to cool down

Herman Pfannensteil and Floyd Mulder of the Norton County Road Department met with the commissioners at the July 22 meeting to discuss the need for a fan in the building.

Two bids were put in on a 3 speed 36 inch 14500 air delivery hurricane fan. Norton Carquest turned in one for \$2,642.21 and Roys Sales and Service turned in one for \$2600. This fan would move more air then the one the state has currently. Commissioner Charles Posson questioned the noise level and commissioner R.A. Peterson ques-

tioned if the building had windows that could be opened up. Yes, it would be noisy and with the open windows cross ventilation would be beneficial Pfannensteil stated. Commissioner Richard Thompson asked if there was money in the budget for the fan and Mr. Mulding stated that he has spoken with Justina Smith about it and she stated that there was enough money to purchase it. Treasurer Robert Wyatt looked to find that the department had used 35 percent of its total budget for the year as of the end of June to verify that the funds were available.

#### Other items for commissioners to address

Four issues were brought to the commissioners meeting on July 22.

First, bids were looked at for two vehicles up for sale. Treasurer Robert Wyatt brought the sealed bids to the table before the commissioners and opened them. Five bids were sent in on the Chevy van and two for the Ford Diesel truck. The van and the trucks highest bids came from Doug David. He bid \$1391.11 for the van and \$1,976.01 for the Ford. Commissioner Peterson said that they were just sitting collecting dust so why not take the bids and get rid of both. Commissioner Richard Thompson motioned to accept the bids

for both and commissioner Posson seconded the motion passing it.

Another topic brought to the meeting was the insurance for the fair. David Davis of Boxler Insurance Agency brought in the Indemnity Policy showing one million dollars of coverage per occurrence. Without the insurance the fair couldn't have run the rides. The commissioners thanked Mr. Davis for getting the coverage needed.

The third item on the agenda was a visit from Dustin Daniels of Foley Equipment. Mr. Daniels came to the meeting to invite the commissioners to a motor-graders tour in Little Rock Arkansas. "A group of about 60 people typically attend", Daniels said. The

group will tour the CAT factory and then the Remington Ammunitions factory. Commissioner Posson and Peterson plan to attend. The tour will take place August 6-8.

Mr. Daniels asked how the equipment operators were getting along with the new graders and commissioner Posson stated that they were liking the joy sticks but typically a lot of glass had been broken in the doors. This is very common on this type of equipment and to be expected.
