Harriett Gill reported the Airport Board met and discussed the crop tower, the Airport Improvement Plan, and the Airport budget. They also elected officers.

Donna Foley reported the Public Works Committee met with the Downtown Beautification Committee to discuss the pod project located at the intersection of State and Main streets. They discussed the removal and replacement of the pods and light poles, electrical improvements that have been requested and the options for watering plants that will be placed there.

Ron Briery stated the 2014 budget hearing will be held on Wednesday, Aug. 7, at 5:45 p.m., at City Hall.

Roberta Ryan stated there were 55 kite flyers at the Norton Area Chamber of Commerce fireworks event and they served 325 meals. Ryan also said the Utility Committee is discussing the replacement of infrastructure, and is looking at the water lines on two blocks, Wilton and Jones streets, and the block south of the Unified Office on Kansas Avenue. Money will be included in next year's budget to start those repairs.

The Norton Classic Cruisers thanked the City for all of the help getting the car show event done. Jeff Urban thanked staff for working overtime because of an incident with a truck pulling the lines down near the Senior Center, the day before the event.

In other council news: -adopted Resolution #14-2013, authorizing the abatement of conditions under the environmental code as to property located at 1007 N. Norton Street.

-authorized city crews to remove the four pods on the downtown corner of State and Main streets, and to coordinate this work with the Downtown Beautification Committee.

-adopted Resolution #15-2013, amending the City's general sidewalk replacement policy.

-approved the Rescue Agreement with Norton County. Under this agreement, Norton County agrees to pay the City of Norton \$10,000 per year until the contract is terminated, and the City will provide a rescue vehicle

and coverage at all emergencies in the County to which a radio dispatch is requested.

-approved Don Mordecai's request to have the annual Disc Golf Tournament in Elmwood Park on Sunday, Aug. 4.

-authorized the purchase of a mobile refuse cart lifter from Elliott Equipment of Lincoln, Neb., at a cost not to exceed \$5,500; this is the same company the trash truck was purchased from, and the company is giving a discount.
