In their first match against Cheylin, the Lady Huskies played great, winning 25-14 and 25-8.

"We passed the ball well to our setters and got some great hits," said head coach Kirsten

#### Baird.

Sophomore Brooke Baird led the Huskies with seven kills, followed by junior Kortney Cunningham with six. Cunningham also led the team in blocks with five and sophomore Sarah Baird had one block.

Serving statistics are as follows: Khrissanna Van Patten 12 points, Kortney Cunningham 12 points, Brooke Hammond 9 points, Shayna Vincent 9 points, Brooke Baird 4 points and

Makayla Smith 3 points.

The Huskies second match proved to be a little more difficult. It took three sets for the Huskies to dispatch of Wheatland/Grinnell, 25-23, 18-25, 25-17.

"Our girls were really ready to play and won in three. We hit well and had some great blocks. This was an exciting win for the girls and really gave them a boost of confidence," said Baird. Once again, Brooke Baird led the team in kills with 14, followed by Cunningham with 6, Hammond with 3, Vincent with 2 and Van Patten with 1.

## Huskies football season opener ends in defeat

*mstephens@nwkansas.com* The Northern Valley Huskies opened the 2013 campaign in Alma, Neb., on Friday, Sept. 6, losing by 10 points to the Cardinals, 38-28.

Things looked promising for the Huskies early on when junior running back Phillip Bryant broke free on a 63 yard scamper to the end zone. The point after failed but the Huskies led 6-0 after the first quarter.

Unfortunately for the Huskies, the wheels came off in the second quarter. In a span of less than four minutes the Cardinals scored three touchdowns. Jarrod Bantam scored the Cardinals first touchdown on a 15 yard run, the PAT failed, tying the game at 6-6. The Cardinals took the lead a minute and 41 seconds later on a 7 yard Brady Stuhmer run. Stuhmer also made good on a 2-point conversion, passing to Terek Molzahn, 14-6 Cardinals. Then with only 45 seconds remaining in the half Stuhmer scored again, this time on a 1 yard plunge, the PAT failed, but the Cardinals led 20-6 over the Huskies at the break.

The Huskies didn't fare any better in the third quarter as the Cardinals scored three more unanswered touchdowns. Early in the quarter Molzahn scored from 1 yard out increasing the lead to 20 points, 26-6 over the Huskies. Late in the third, the Cardinals put the game out of reach. Chris Simmons had a 4 yard touchdown run and Jarrod Bantam added a 5 yard touchdown run of his own giving the Cardinals a commanding 38-6 lead going into the fourth quarter.

The Huskies kept fighting


however, scoring three touchdowns late in the game. Senior quarterback Hunter Chandler found the end zone from 9 yards out and passed to junior Clint Cole for the 2-point conversion, cutting the lead to 24 points. With less than two minutes remaining, junior running back Philip Rupp went for a 68 yard run through the Cardinals defense, the PAT failed, and the Huskies trailed 38-20. Rupp would follow up with a 5 yard touchdown run and score the 2-point conversion, cutting the lead to 10 points, but that's as close as the Huskies would get, losing the season opener 38-28 to the Alma Cardinals.

**Coach's Comments:** 

"It was a hot, physical football game. We had the lead until late in the first half. In the span of a little over four and a half minutes we went from up 6 to down 14. A couple of fumbles and a long punt return contributed to our collapse. We lost Jordan Baird to an injury at the end of the first half. Alma took control early in the second half. Our back-ups played well at the end of the game," said head coach Chuck Fessenden.

Huskies rushing: Hunter Chandler - 25 carries, 161 yards, 6.4 average, Jordan Baird - 11 carries, 45 yards, 4.1 average, Phillip Bryant - 14 carries, 92 yards, 6.6 average, Philip Rupp - 5 carries, 89 yards, 17.8 average, Carson Wallace - 1 carry, 7 yards, 7.0 average, Matt Stutsman - 1 carry, -10 yards, -10.0 average.

The Huskies will look to bounce back on Friday, Sept. 13 at 7 p.m., when they play their home-opener against Triplains/ Brewster.
