# Husky team runs well at Nebraska

Cool, damp weather greeted the Husky cross country team as they arrived at the Alma golf course for the Alma Invitational. Despite the conditions each of Northern Valley's runners ran well and posted good times. Three of the four earned varsity medals, and three also posted best times.

In the girls race Brooke Baird ran in sixth place for the first mile, then worked her way forward to finish fourth. Allison Keith ran a steady race to place 23. It was the first 5,000 meter race for either young lady, as Nebraska changed the distance for their girls this year. Baird's time was 23:48 and Keith's was 31:25.

In the boy's 5K Macy Kasson and Camden Cox each medaled. placing 10th and 14th, respectively. Cox ran a personal best time for the 3rd race in a row, finishing in 21:37. Kasson ran a time of 21:15.

The Alma meet offered a rare opportunity for the Northern Valley Junior High to compete in cross country. Seven athletes ran a 1.2 mile course, with four well. Aiden Baird was 8th and receiving ribbons for placing in the top fifteen places. 8th grade girls Makensy Schroeder and Chaylee Lowry placed second and fourth, respectively. Schroeder finished with a time of 8:44 and Lowry earned a time of 9:04.

Four seventh grade boys and one eighth grade boy ran as ran a time of 8:57. Jesus Saenz was not far behind in 10th, with a time of 9:16. Also running were Brady Rogers (16th, 10:15), Ross Cole (18th, 10:37) and 8th grader Turner Linner (24th,12:05).

It was an all around good day. The high school runners are becoming stronger runners as the season goes along. The weather made it difficult to improve times, but each person competed well. The junior high runners showed a lot of promise as well as toughness.
