Emergency management is up to speed

cynthia.haynes@nwkansas.com Norton County is up to speed on everything it needs for its Local Emergency Planning Committee, the county commissioners learned at last week's

meeting.

Justina Smith, county emergency management director, told the commissioners that after an exercise, that was scheduled for that evening, all the necessary work would be done for the committee.

"We are good to go with all our cer-

tification for LEPC," she told the commissioners.

All the annual notices have been done and the group has several new members, she said.

Ms. Smith also gave the county a draft of her working calendar for the rest of this year and the first six months of 2014.

She has a lot of training for various county departments, many meetings to attend both in Norton and out of the county and several exercises planned for Homeland Security.

being set up, she said. The first year these were done there were about 45 people attending, she said. The second year it was up to 80. More people are interested in helping out and knowing what to look for during bad weather.

She noted that the weather service is also giving out more specific warnings. Instead of saying that there is dine-size hail expected, the service will say that and add what type of damage that size hail might cause.

Ms. Smith said that right now she is

Weather spotter classes are already trying to get identification cards for all emergency workers and other county employees, who might need them - like the commissioners, who are technically

head of the county emergency services.

Ms. Smith said that the emergency medical service personnel, road department workers, health department personnel, firefighters and law enforcement officers all need the identity cards.

Some have gotten them, she said, and some are still in the process. The county fire departments, which are mostly volunteer, are probably the hardest to pin

The county commissioners accepted the low bid for commercial-grade carpeting with no padding for the office area only (not the break-room area) at their meeting last Monday.

Don's Floor Covering of Norton was the successful bidder with \$1,262 for the carpeting.

The commissioners all agreed that the office area at the road and bridge department needed to be redone.

"It's pitiful," remarked Commissioner R.A. Peterson.

Since the break room has a painted floor, the commissioners agreed with road and bridge Office Manager Becky Wilson that that area should just get repainted and it would look fine.

The commissioners suggested getting a prison work crew to do that job.

In other business, Mrs. Wilson reminded the commissioners that she has been on the job for three months now and asked that they do a job review of


