ents from 11 to 92 years of age." Bodyworx is the first successful incubator business in the Norton program, according to Nuttycomb. She used to work as a veterinarian technician, but "it didn't pay the bills." In 2010 she took a beginning massage class and said that it turned into a part-time job that went well enough for her to consider her own business. Amber also said that being her own boss and making her own schedule was very appealing.

Bodyworx offers many unique products as well, such as scented candles that smell like bacon, peanut butter cookie. cornbread, zucchini and cappuccino, psoriasis cream and Herb Haus, a full line of herbal products containing organically grown herbs and oils and locally made in Ellis, Kan., and exclusive to Bodyworx.

Bodyworx also has a fullservice hair and nail salon. Stylist Paige Harding offers haircuts for women for \$20, men's for \$12 and children 10 and under \$12 haircuts. Harding also offers hair color from \$45 and up, pedicures, from the 60 minute Express Pedicure for \$30 to the Spa Pedicure for \$40, manicures, from the Express Manicure for \$15 to the Spa Manicure for \$35, waxing, including eyebrows, lips, chin and full

Bodyworx isn't just for the ladies either, 30 percent of its clientele are men. Tax credits are now available through local funds

Tax credits are available through the Norton County E-Community Fund and the Net-Work Kansas Partner Grant Program. \$750,000 in tax credits have been allocated to this program. The minimum allowable tax credit per year is \$187.50; the maximum is \$50,000. The deadline to purchase these tax credits is December 4, 2013.

Donors receive a 75% state income tax credit for their donation. A tax credit is a dollar-

for-dollar credit against state as well as public sector organiincome tax liability. Donors are also eligible to receive a federal and state tax deduction and should consult with their individual tax specialist to determine the amount of any deductions.

NetWork Kansas was created as a key component of the Kansas Economic Growth Act of 2004 to lead collaborative efforts between education, research and outreach services, zations, in order to serve potential and existing entrepreneurs statewide. An integral part of this effort is providing seed capital to entrepreneurs and small business owners in rural and distressed areas of Kansas. The Kansas Center for Entrepreneurship Tax Credit was created to stimulate this effort.

Donations to the Center provide matching loans and/or grants through local or regional non-profit business support providers who are also NetWork Kansas resource partners. The funds are made available to businesses located in rural areas who are starting or expanding a business.
