

Osborne wins Eight Man title

Osborne won the Eight Man I state football championship, La Crosse advanced to the Class 2-1A state championship game and Beloit advanced to the Class 3A state title contest with victories last weekend.

Osborne (13-0) finished an unbeaten season and captured the school's first state title in football since 1983 with a dominating 56-8 win over Hodgeman County (12-1) on Saturday afternoon in Newton. In the win, the Bulldogs came very close to hitting their state-best average of 58.7 points per game.

Osborne ended the contest early when senior Maverick LeRock's fifth touchdown with 7:17 to play brought the 45-point mercy rule into effect. The Bulldogs broke the game open with three touchdowns in the second quarter to lead 28-0 at halftime, then put it away with another 14 unanswered points to start the second half.

Hodgeman County was no offensive slouch this season, averaging 49 points a game prior to Saturday's loss, but they had only five first downs in the game. Four came on one first half possession and the fifth on their lone touchdown of the game.

Two of LeRock's touchdowns came on passes from sophomore quarterback Jake Tiernan while senior Kenton Ubelaker accounted for the Bulldogs' other three touchdowns. He also had two touchdown catches from Tiernan and a 62-yard touchdown run in the third quarter that made it 42-0.

In the Eight-Man II state championship game, also played in Newton, Baileyville (12-1) outscored Sharon Springs (12-1) by a score of 42-13 for the title.

In a Class 3A semifinal game in Scott City, No.1 state ranked Beloit (13-0) defeated the defending state champion Beavers (11-2) by a score of 36-13 to advance to the title game.

Senior quarterback Payton Vetter was the catalyst for the Trojans on Saturday. He was the star of the bone-crushing ground game and threw a few key passes, as well. Vetter carried the ball 19 times for 140 yards and two touchdowns and had one touchdown pass. He was 5 for 9 passing for 92 yards.

After trailing early, Beloit came back to take a 22-13 half-time lead and the Beavers were held scoreless after intermission.

In addition to Vetter's yardage, the Trojans' leading rusher, Bowe Behymer carried the ball 27 times for 165 yards.

Beloit will take on perennial eastern Kansas power Silver Lake at 1 p.m. this Saturday in Gowans stadium in Hutchinson for the state championship. Silver Lake fell to Scott City 28-21 in the 2012 championship game.

In Class 2-1A, La Crosse (12-0) outscored Meade (10-2) by a score of 38-24 to advance to the state championship game.

Baileyville quarterback Dustin Rottinghaus threw for 399 yards and five touchdowns in leading his team to the 42-19 win over Sharon Springs for the state championship.

It was the second consecutive state championship and fourth in six years for Baileyville, who will consolidate with Nemaha Valley following the 2013-14 school year. Sharon Springs was making its first title game appearance since winning state in 2006.

Upcoming championship games

In Class 3A, Beloit (13-0) will play Silver Lake (12-1) at 1 p.m. in Gowans Stadium in Hutchinson this Saturday for the state championship.

In Class 2-1A, the state championship game between La Crosse (12-0) and Centralia (12-0) will be played at Lewis Field Stadium in Hays on Saturday with kickoff set for 1 p.m.
