The community of Wamego, population 4,485, located in Pottawatomie County, is going all out to host the 25th annual Kansas Sampler Festival. The festival will be held Saturday, May 3 and Sunday, May 4 in Wamego City Park.

# Email scam targets energy customers

Several Midwest Energy customers have reported an e-mail scam, where an e-mail with the subject line "Energy Statement" arrives in their inbox. Though the body of the E-mail reads "PG&E Energy Statement," the letters PG&E are difficult to read.

The 'statement' shows a large account balance, and urges the reader to "click here" to see their most recent statement. But the link takes the user to a page that is set up to install a variant of the Kuluoz malware, a Trojan that's designed to download additional threats onto infected computers, and opens their computer to other malware.

Pacific Gas and Electric, which serves customers in California, has alerted its customers to the scam on its webpage; however, it has spread to computers nationwide from the e-mail contacts list in infected computers.

"We urge anyone who gets an e-mail like this to delete it, without opening any links or attachments," said Michael Sadeghi, Midwest Energy's Director of Customer Service. "If you ever receive a call or e-mail from someone claiming to represent Midwest Energy, feel free to call us at (800) 222-3121 to verify the person's identity," he said.

consideration the relative harms to mailers, would simply invite the PRC into regulating the advertising marketplace. It is not enough. Our industry needs tighter rules on NSAs.

**ACTIONS:**

Sen. Tammy Baldwin, D-WI, is prepared to introduce an amendment to strike the rates section, Section 310, and leave the current law as is. If you have senators on the committee, please ask them to join her. But even if your senators are not on the committee, please contact them NOW and tell them:

1. The Postal Service remains a powerful government monopoly that must not be de-regulated to this degree.
2. Setting a price cap at the total-mail level, rather than upon each mail class, invites price manipulation by USPS.
3. The Postal Service badly needs some other provisions in this bill, such as one to recalculate crippling burdens from

employee benefit programs imposed by Congress in 2006. But while Section 310 remains, many who otherwise support postal reform, cannot promote the Carper-Coburn bill.

4. The Postal Service should not engage in NSAs for advertising. Its monopoly pricing powers distort the market and improperly put the Board of Governors and PRC into a role of advertising regulators.

Also, please join NNA on March 13 in Washington when publishers take their case to Capitol Hill. NNA is the voice in Washington for Community Newspapers. Postal Reform legislation is needed. Once completed, it will be in effect for years to come. Act now to protect your industry.

# KanCare is primed for February 1 implementation of new services

The federal Centers for Medicare and Medicaid Services and the State of Kansas are making substantial progress in discussions that would allow the state to move forward in including long-term services and supports for Kansans with intellectual or developmental disabilities in KanCare, the state's integrated Medicaid managed care program, starting Feb. 1.

The Kansas Department of Health and Environment had proposed the Section 1115 amendment would take effect Jan. 1, but federal and state officials agreed to take additional time to resolve issues related to the existing 1915(c) waiver for intellectual or developmental disabilities members, and to review and fully consider public comments offered during the federal comment period, which ran through Dec. 24, 2013.

The result is a framework designed to ensure KanCare will provide members with the comprehensive care and services they need to thrive in their

homes and communities. The terms of the agreement are being completed.

"We appreciate the detailed discussions and partnership with centers for Medicare and Medicaid Services that have produced a plan of action to allow KanCare to start working as a comprehensive, integrated plan for all its members," Lt. Gov. Jeff Colyer, MD, said.

As the Feb. 1 date approaches and before completion of the final agreement, the State also scheduled a special stakeholder listening session for Wednesday, Jan. 22, that allowed consumers, their families and caregivers, and other stakeholders an opportunity to learn about some of the key protections that have been put in place for the transition, and to offer their suggestions and advice for a successful implementation. Medicare and Medicaid service officials also participated in that call.

The two-hour conference call was divided into two sections. The first hour, from 8:30-9:30

a.m., will be devoted to consumer and family issues, starting with a discussion of how targeted case managers will interact with managed care organization care coordinators in the KanCare model. The second hour, from 9:30-10:30 a.m., was for providers and other stakeholders and began with a discussion of billing and administrative protections in place for the transition. Time was available in each portion of the call for other comments and discussion.

The Kansas Department for Aging and Disability Services will also provide written notification to consumers of the impending transition by letter.

"We appreciate the feedback stakeholders have provided so far, and look forward to continuing to work with them to ensure that KanCare makes a positive difference for its members," Kansas Department of Aging and Disability Secretary Shawn Sullivan said.
