USD 211 to change schedule next year

will have longer school days but a shorter school year. Presently, students begin school at 8:30 a.m. and get out at 3:30 p.m. The Board of Education, U.S.D. 211, ratified the agreement with the National Teacher's Association at its meeting on Monday, Feb. 10, to begin next year's classes at 8:15 a.m. and conclude at 3:30 p.m. The longer school days, however, will mean the

school year will be six days shorter.

Superintendent Greg Mann said the Next year Norton school students reason for the change is primarily a will be served six fewer days. "It's not school, a lot of the kids are already at school at 8:15 a.m., which we supervise," said Mann. "The teachers are teaching at that time." The same is true at the junior high. According to Mann, a majority of the junior high students are at the school at that time, but not so much for the high school students.

The change in schedule will also

save the district a little money, because buses will run six fewer days and meals less," said Mann.

Possible new legislation to expand businesses

There is a chance that a sales tax exemption for new or expanding businesses may come before the legislature this year, Norton City and County Economic Director Scott Sproul told the county commissioners last Monday and his board on Tuesday.

"It's idle conversation at this point,"

Mr. Sproul told his board but said that he wanted to know where the city, county and his board stood on the matter before saying that Norton is interested in it or not.

The idea, he said, is to offer a sales tax abatement on construction materials for new or expanding businesses. The thought is that only those businesses that are investing between \$250,000

and \$3.5 million would qualify, he said,

He noted that there would be a loss of sales tax at the time but that should be made up by the extra business in the community over time.

and it would only be a one-time thing.

Board member Jerry Jones asked if that would include local sales tax also such as the one that the City of Norton passed to pay for its new swimming

"We passed the sales tax for the swimming pool, the state didn't," he

Mr. Sproul said he didn't know but it would be a good thing to check out. Board member Donna Foley said she
