The Federal Aviation Administration Safety Team will put on "Super Safety Saturday," a set of presentations from 9 a.m. to 3 p.m. on Saturday, April 5, at Colby's Shalz Field Municipal Airport. The event is about safety, but is open to anyone with an interest in aviation. A hot lunch

The meeting will include discussions about aircraft ownership and maintenance, controltower operations, automation and special-issuance licenses for pilots with minor medical problems.

Mark Ostmeyer of MC Aviation Services, manager of the airport, will give one of the presentations. The other three speakers include two industry representatives, David Dewhirst, Michael Scheiman, and James Lamb, a member of the agency's safety team. Ostmeyer said he especially would welcome anyone from the International Flying Farmers club, which has a convention in town that weekend.

This will be the first safety day here in several years, Ostmeyer said, although he tried to have them every year in the


