Bridge repairs discussed

dpaxton@nwkansas.com Members of the Norton County Road and Bridge Departments and a Penco representative met with the Norton County Commissioners at the June 16 meeting to discuss future plans for the repairs to the Densmore Bridge.

Mark McKenna, Becky Wilson and Floyd Richard along with Penco representative Jeral DeBore and Moni El-Aasar of BG Consultants Inc. looked at options for repairs. El-Aasar reported that there are hairline cracks on the interior beams of the bridge and McKenna reported that the deck was falling apart. The bridge sits east of Densmore and sees a lot of traffic with heavy loads. They were

there to decided on whether or not to do a temporary or permanent fix.

El-Aasar said that to extend the life of the bridge it would be a good idea to replace the deck, "It would be money well spent." he said. He suggested fixing it one half at a time so that it can remain open by going back to steel beams instead of the prestressed concrete currently in place.

DeBore of Penco made these suggestions, he said to use old stringers but to put them all the way under the current bridge, it would take nine steel beams for \$32,000 and by doing this, no permits would be required or if the county chose to replace the substructure it would run about \$60,000. No matter what, all

three spans must be reinforced. El-Aasar stated that he would

get the permits, blueprints and survey going so they can start next spring and McKenna said that was great because he would do the work on it. The commissioners agreed to think it over since construction wouldn't start until next spring and revisit it at a later date.

Another bridge in the southwest corner of the county was discussed because it needs to be straighten out. The county currently has the materials to do the repairs and even though the Densmore bridge is more critical, the commissioners agreed to have work started on this bridge.
