## Lady Jays tracksters had an outstanding season

The Lady Jays won three meet championships, finished runnerup in three more plus a third and fifth and seventh in the toughest regional in the state.

High point scorer was senior Bailey Ambrosier with 163.5 points.

Season review

The girls season began on Monday, April 7 in the Kiwanis JV Track Meet in Smith Center. Norton placed seventh. Freshman Macayla Kent placed third in the 1600 meter run in 7:30.39. Freshman Josie Otter finished sixth in the shot put with a heave of 25'.

Track and field action really picked up on Friday, April 11 when the Blue Jays hosted the Norton Invitational Track Meet at Travis Field on the Jep Byrum Track. The Norton girls just missed the championship. Colby scored 142 points, followed by Norton, 140; Oberlin, 113; Logan, 74; Northern Valley, 58; Smith Center, 22.

Senior Bailey Ambrosier picked up where she left off in 2013 by winning the pole vault with a clearance of 10'6". She also placed second in the 400 meter dash in 1:04.55. Norton's 4 x 800 meter relay team of Bailey, senior Katelyn Engelbert, junior Sierra Griffith and sophomore Casey Ambrosier placed second relay with a clocking of 4:29.09. her first time to run the event in a meet. Freshman Starla Tishhauser finished sixth in the 1600 meter run in 8:04.37.

The Plainville Invitational Track Meet was held on Tuesday, April 22. Norton finished runner-up to champion Oberlin. The previous Norton 4 x 800 meter record was held by Bailey Ambrosier, Astrid Moen, Kamilla Jones and Dustyna Sprigg. They set the record of 10:09.03 at the Regional Meet in 2011.

Be It Resolved that: The above-named achool board shall be authorized to make an annual tex levy for a period <u>not to exceed FIVE (5) years</u> in an amount <u>not to</u> exceed HGHT (B) mills upon the tensible tangible property in the achord district for the purpose of exquisition, construction, reconstruction, repair, remodeling, additions to, furnishing, maintaining and equipping of school district property and equipment necessary for school district purposes, including (1) Acquisition of computer software, (2) exquisition of performance uniforms; (3) housing and boarding pupils enrolled in an area vocational school operated under the board; (4) architectural expenses; (5) acquisition of building sites; (6) undertaking and mainterrance of extresion control projects; (7) acquisition of achord busins; and (8) acquisition of other fixed assets, and for the purpose of paying a portion of the principal and interest on bonds issued by cities under the authority of K.S.A. 12-1774, and amendments thereto, for the financing of redevelopment projects upon property lacated within the achoal district. The tax levy authorized by this recolution may be made, unless a patition in apposition to the same, signed by not less than 10% of the qualified electors of the achool district, is filed with the county election cificar of the home county of the achool district within 40 calendar days after the last publication of this resolution. In the event a petition is filed, the county election officer shall aubmit the question of whether the tax lawyshall be authorized to the electors in the school district at an election called for that purpose or at the next general election, as is apecified by
