

Held at the Jeter Isely farm northwest of Wheeler, the wind whipped around the riders except when they were down in the canyon areas. Occasionally, there were a few drops of rain but not enough to make a difference in the ride.

As riders reached the high point, they were treated to a panoramic view of the country side. Here, Gary and Bonnie Cooper had water available.

This was the first ride in 20 years that Mr. Cooper, who is one of the main coordinators, has missed. However, he and others are already planning the next ride on the second Sunday in October 2011.

As the riders crawled off their mounts after over 2 hours of riding, the 4-H horse club members had a meal waiting for them which was served in the Isely's yard.

Registration books close Monday

The general election will be held years or older and a citizen of the on Nov. 2. Those who have not registered to vote need to do so before Oct. 18 when the books close. They will remain closed until the day after the election, Nov. 3.

People may register in St. Francis at the county clerk office in the courthouse and the St. Francis City Clerk office. In Bird City, people can register at the First National Bank on Bird Ave.

To register, a person must be 18

United States. When a person has registered, the registration will continue to be valid until the voter changes their name by marriage, divorce or legal proceedings or changes their residence.

People can apply to register in person or by mail. The application forms will be provided by the county election officer, Terry Miller, in the clerk's office at the courthouse in St. Francis.
