damage, crop damage, water over roadways, just to name some.

- Have a plan of action before the storm. If the home or work does not have a safe storm shelter such as basement, make sure arrangements are made as to where to go.

- Keep battery powered television or radio, and flashlights available for power outages.

- Keep track of the weather when planning outdoor activities, and a safety plan should severe weather arise.

- Those having special needs such as oxygen, hearing impairment, wheelchair, dementia, etc., should make plans for the severe weather before it hits.

- Take along critical medical supplies, prescriptions and documents when taking shelter from the storm.

Seek shelter

Those traveling through Cheyenne County or residents who have no place to go in their homes can find shelter in two places. Those in Bird City can go to the basement of the Lutheran Church on 405 Ketcham; in St. Francis, go to the bottom floor of the courthouse at 212 E. Washington.

paid. The city then made a least agreement with Bankwest St. Francis for the remaining money needed.

Mr. Fitzgerald pointed out that with 32 residents, the Society would be losing money. For the first year, it is estimated that they will have a loss of between \$150,000 and \$200,000. They have committed to operate the facility at this loss until July 1, 2012.

This time span will give the commissioners and the residents of the county time to make plans to take over the operation, expand the Village campus to include an addition for 12 more residents and an assisted living facility for 10.

The Society plans to turn over the entire campus including the apartments for \$1 with the Society operating the center through a lease agreement.

If the residents decide not to take the ownership of the facility with the intentions to expand, the Society will close the nursing home.

Mr. Fitzgerald said this should not be considered as a threat. It is a matter of economics. We cannot continue to operate at a loss and, without the additional beds and assisted living, it will not make the money needed to support it.

Mr. Hensley had drawings of the Village as it is today (Phase 1); the plans with the hallway and dining area (Phase 2) and a proposed plan for the additional resident's rooms and the assisted living. (Phase 3).

The cost for the additional buildings was estimated at \$4.3 million to \$4.5 million. It was less than what a completely new facility would be and, could come in even less than the proposed figures.

Mr. Keller asked Mr. Fitzgerald about placing the assisted living in Bird City. Mr. Fitzgerald said it would probably lose money. With the all the services on the same campus in St. Francis, there is a need for only one kitchen, one laundry, one cleaning service... and the list went on. The only du-

plication for the Bird City assisted living would be the administrator and he felt this person could oversee both, despite the miles.

Mr. Fitzgerald estimated that it would take about three years to finish the entire project.

Mr. Keller asked why, when the west wind was renovated, didn't the Society install the new air conditioning and heating project, which had been scheduled before fire.

Mr. Fitzgerald said they were focused on getting the facility

open as quickly as possible and the funds were no longer available.

Come before the voters

The future of the Village will go before the voters. Terry Miller, county clerk, said the general election in November 2012 will be too late because the Society plans to turn the facility over to the county by July 1, 2012.


That will mean a special election will be held, he said. However, the date and time are yet to

be set.

Mr. Keller, who is one of St. Francis' Community Builders, will see about organizing public meetings where residents can ask questions and hear what Mr. Fitzgerald has to say.

In the meantime, the commissioners will look into what it takes for bonds and other funding. Mr. Foster said the state tax credit program will still be available for another year and there may be other grants and funding available.
