Swimming pool

Bruce Swihart, Swimming Pool Committee member, said the pool would close on Aug. 26. The school will use it from Aug. 29 to Sept. 2. During that time, there will also be aquasizes.

If the budget will allow, Mr. Swihart said, Mikaela Grace, pool manager, has offered to do some work at the pool so it will be done when the pool opens in the spring. Mikaela doesn't begin college until the middle of September and would be able to complete the work before she goes. The council approved.

Police report

Shane Guggenmos, police chief, had information on the 800 megahertz radios. He had three quotes for four radios. Custom Radio Communications' quote was \$5,736; First Responder, \$7,500; and Motorola, \$8.894

Building permits

Building permits were approved for Travis Jensen to run concrete; Randy Isaac, tear down a building; Melvin Dunn, erect a storage building: Rob Schiltz, build more storage sheds; and Roger Applegate, put in steps.

There was also a permit for the St. Francis Equity to pour cement but the cement was poured before the permit was approved. Consequently, it is over a sewer line. The permit was approved with the agreement that if there is a problem with the line, the Equity will be responsible for tearing the cement out.

Superintendent's report

Superintendent Landenberger reported that the water inspector had been in St. Francis and everything is fine with the wells.

There is a problem with one of the pumps at the sewer lift station. We have tried to fix it, Mr. Landenberger said. But, there is still a failing pump that needs to be fixed. It will cost \$8,500 for stainless steel junction boxes and wiring. The box needs to be sealed.

The pump costs \$3,500 but the city had one on hand. It is a requirement, he said, that the city has an extra one on hand.

The lift is by the ball diamond and could shut down any time, he said. It has to be fixed immediately.

Council comments

The council talked about the fact that the delinquent tax list published in The Herald had the city owing taxes with the former owner of the Smith residence on Emerson Street. The city attorney said the city doesn't own the Smith property so doesn't owe any taxes.

Mr. Swihart said that a letter had been sent out by the Ministerial Alliance noting that contributions are down and use is up. People are being served that hadn't been served before.

We need to keep in mind as we are spending, he said, that people are struggling.


