Man carrying cross travels on Highway 36

Everyone traveling on U.S. 36 last Wednesday could not help but notice a man carrying a 40-pound cross on his shoulder and pulling a 180-pound trailer.

Mike Rumsower was passing through on his way to his destination and home in Gallitan, Mo. This journey was started on March 30 by walking across the Golden Gate Bridge in San Francisco, Calif..

It has taken longer than anticipated to get this far because of many difficulties. On this morning, he was just starting out after spending two days in the Empire Motel in St. Francis because he was not feeling well. When asked when he plans on reaching Gallitan, he said, "God's timing is different than mine," but Mr. Rumsower is guessing he will not reach his destination for at least another month

When Mr. Rumsower was first approached, Phyllis Carson, Bird City, was just leaving after returning to bring him an Orange Crush soda, and his first words were, "Will this be from the heart and will it be about God and not

wanted him to do. On faith without advance training or backing of any kind, he packed his trailer with a tent, sleeping bag and other necessary items and set out on his journey.

"It has been trying, struggling, exciting, fun and definitely God proving," he said about his experience. People have been good to him, he said, and gave him food and money, but others have spit on him, called him crazy, and even pointed a gun at him. One man stopped and carried his cross for him for time enough to rest his shoulder.

Then he told this story: When he was walking through the desert, he was hot, thirsty and hungry and screaming to God, "Why am I here?" "What have you put me here for?" All I want, he said, was a burrito supreme from Taco Bell.

He had walked for over two and a half hours not seeing anyone when a car came over the hill and

In sharing one of his visions he had before starting his journey, he saw a field of lavender with scorpions and snakes. In his journey through the dessert, he found out if he rubbed lavender oil on a horsehair rope and put it around the tent, it kept the snakes and scorpions from crawling into his tent at night. In places where he cannot find a place off from the road to sleep, he sleeps in a

His goal for Aug. 24, was to reach Atwood where he had reservations made for the night. After approaching Wesleyan what other people have posted,

to check things out. The church was feeding dinner to the group with the Todd Becker Foundation before their performance at the Chevlin School.
