Hospital board has an audience

nfiala@nwkansas.com The Cheyenne County Hospital Board met on Thursday, Oct. 27. There were numerous visitors in attendance and they were addressed first.

Jenny Newblock, coordinator of Hospice, addressed the board and said the organization would like to help with hospital equipment and furniture. Edie Wolters, volunteer, then introduced herself and the other volunteers in the organization. Elmer Kellner addressed the board about a love seat that had gone missing. He said he'd heard it had been sold at auction. Hospital administrator Les Lacy said he did not know about this specific issue, but that similar things had happened in the past and that he would make more of an effort to communicate with the hospice in the future. Dr. Mary Beth Miller pointed out that refurbishing these items is sometimes not possible as infection control can be a concern.

The other visitors in attendance were prompted by a letter to the editor in the newspaper to be there, concerning the hospital looking into purchasing a house right behind the clinic just after a mill levy increase. This was on the agenda, so the board skipped to this part in the meeting and Mr. Lacy addressed the issue.
