# Seven seniors play their last game for the Indians

nfiala@nwkansas.com The Indians played their last football game of the year on Friday, Oct. 28, against the Rawlins County Buffalos. It was a hard fought contest, but Sainty lost the game 16-8 and ended up with a 2-7 record for the season.

Sainty had wins over the Holyoke, Colo., Dragons and Wichita County Indians.

There were eight ball players with a total of 2,347 rushing yards in 424 carries for the team, averaging 5.54 yards per carry. The team also scored a total of 170 points this season, averaging 18.9 points per game.

Thomas Douthit was the lead rusher and scorer for the Indians with 10 touchdowns and three conversions in 962 rushing yards and 131 carries. Dylan Wolaver had four touchdowns and one conversion in 695 yards and 131 carries. Michael Leibbrandt had four touchdowns and one conversion in 218 rushing yards and 34 carries. Ty Zweygardt had four touchdowns in 338 rushing yards and 43 carries. Cade Bracelin ran in two touchdowns and a conversion in 126 rushing yards and 46 carries, and also kicked two through the up-rights for extra points. Brock Zweygardt and Lane Hoffman both ran in a twopoint conversion and both Zach Gienger and Foster Grant scored safeties during the season.

On defense, Leibbrandt had 26 unassisted tackles and 35 assists. Gienger had 25 lone tackles and 37 assists. Douthit had 18 lone tackles and 54 assists. Grant had 14 solo tackles and 29 assists. Dylan Peter had 13 unassisted tackles, 18 assists and one quarterback sack. Wolaver had 12 lone tackles and 21 assists. Steven Nelson had 11 lone

tackles and 24 assists. Jonathan Butler had 10 solo tackles and 12 assists. Dillion Straub had nine unassisted tackles, 34 assists and a quarterback sack. Gavin Cooper had eight solo tackles and six assists. T. Zweygardt had eight solo tackles and four assists. Paul Nelson had six solo tackles

and 18 assists. Bracelin had three unassisted tackles and 13 assists. Hoffman had three unassisted tackles and five assists. Wyatt Landenberger had three unassisted tackles and four assists.
