Extension to help drought-stricken area

Kansas Gov. Sam Brownback has extended an order temporarily suspending overweight and overheight motor carrier rules and regulations to help efforts to transport hay to livestock in drought-stricken areas.

However, unlike the previous order, this order includes restrictions on travel during nighttime hours and during periods of inclement

This order applies to individuals hauling hay to livestock in droughtstricken areas of Kansas and to those driving through Kansas to make deliveries in Oklahoma and Texas.

The amended Executive Order temporarily suspends the requirements to receive over size permits from the Kansas Department of Transportation, registration and fuel tax permits from the Kansas Department of Revenue and permits

Motor carriers participating in the relief efforts are not permitted

to travel during nighttime hours or during inclement weather condi-

Oversize or overweight loads are not to be transported when visibility is less than one-half mile or when conditions of moderate to heavy rain, sleet, snow, fog or smoke exist, or when highway surfaces are slippery because of ice, packed snow or

Participating motor carriers are limited to a load not exceeding 12 feet in width and does not exceed a height of 14 feet, six inches. Under normal circumstances, haulers are required to get a permit for loads exceeding 8 1/2 feet in width and/ or 14 feet in height. All other applicable state and federal regulations continue to apply, including the requirement of having a valid driver's license.

Executive Order 11-49 amends and extends Executive Order 11-47 until Friday, Jan. 27.

What's So Amazing About Grace?

Book review from the St. Francis Public Library By Philip Yancey

In 1987, an IRA bomb buried Gordon Wilson and his twentyyear-old daughter beneath five feet of rubble. Gordon alone survived. And forgave. He said of the bombers, "I have lost my daughter, but i bear no grudge....I shall pray, tonight and every night, that God will forgive them.'

His words caught the media's ears-and out of one man's grief, the world got a glimpse of
