# Small businesses loans available

Small, nonfarm businesses in nine Kansas counties and neighboring counties in Colorado and Nebraska are now eligible to apply for low-interest disaster loans from the U. S. Small Business Administration. Primary counties in Kansas include Cheyenne and Rice.

"These loans offset economic losses because of the combined effects of reduced revenues caused by excessive rain, high winds and lightning that occurred in Cheyenne and Rice counties from Aug. 8 - 10," said Alfred E. Judd, director of the administrator's Disaster Field Operations Center-West.

Neighboring Kansas counties: Barton, Ellsworth, McPherson, Rawlins, Reno, Sherman and Stafford; Colorado counties: Kit Carson and Yuma; Nebraska county: Dundy.

"Small Business Administration eligibility covers both the Injury Disaster Loans available economic impacts on businesses when the U.S. Secretary of Agridependent on farmers and ranch- culture designates an agricultural ers that have suffered agricultural disaster. Secretary Tom Vilsack production losses caused by the disaster and businesses directly impacted by the disaster," Mr. Judd said.

Small, nonfarm businesses, in farming or ranching are not small businesses engaged in aquaculture and most private, nonmay qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred.

"Eligibility for these loans is based on the financial impact of the disaster only and not on any actual property damage. These loans have an interest rate of 4 percent for businesses and 3 percent for private, nonprofit organizations, a maximum term of 30 years, and are available to small businesses and most private, nonprofits without the financial ability to offset the adverse impact without hardship," he said.

By law, the Small Business Administration makes Economic declared this disaster at the request of Governor Sam Brownback.

coyote's tail. A two-pointer, Rueb said, is easily detected and it is very apparent that almost all the hair in the tip of the tail is white.

Kill block A new style of kill block was used last year. It is a "bench mark" in the contest-calling industry. This newly designed kill block dramatically stops the chances of pooling coyotes and cheating.

The Midwest Coyote Event will have their kill blocks laser engraved with a special logo. This stops teams from making extra kill blocks of their own and also stops teams from pooling coyotes from other hunters in order to increase their harvest count.

"This is another effort that we are taking to make sure that the Midwest Coyote Calling Event is honest and promotes the rules of fair chase," Mr. Rueb said. "The masters of coyote calling just keeps getting better and stronger.'

### 2011 results

Of the 129 teams participating in the 2011 event, 129 teams returned Sunday for check in. The hunters reported seeing 803 coyotes and killed 364.

Last year's top four winners in the Dead Coyote class were: first place were Matt Hebert, Hyannis, Neb., and Justin Brandon, Yuma, Colo., 14 coyotes; second place: Brad Phillips and Luke Seelhoff, Burlington, 12 coyotes; third place: Cenny Burnell, Kaycee, Wyo., and Dave McCartney, Chadron, Neb., 10 coyotes; fourth place: Josh Mahar and Eric Rice, Gothenburg, Neb., 10 coyotes.

Taking first place in the Hevi-Shot Class were Nick Bowley, Loveland, Colo., and Dustin Pat-

terson, Ogden, with eight coyotes. Second place went to Travis Fonte and Eric Schafer, Wray, seven coyotes; third, Johathan Bopp, Loveland, and Matt Brown, Wellington, Colo., seven coyotes; fourth, Lance Long and Matt Smull, St. Francis, seven coyotes.
