The Cheyenne County Clinic dollars are also needed to cover this area were: Greeley County in St. Francis has received \$1,650 from the Blue Cross and Blue Shield of Kansas Foundation.

The clinic was among 28 primary care and community health centers providing care for underserved Kansans to share \$46,200 in year-end grants from the Kansas Foundation. Each clinic received a grant of \$1,650.

These clinics have stretched their budgets to the maximum in order to assure that the growing number of uninsured and underinsured Kansans have access to quality health care, said Marlou Wegener, chief operating officer of the Foundation.

In recognition of the important work these clinics do in the communities they serve, the Foundation is providing each with these funds in the hope that the funds will help them continue to provide crucial health care services to the Kansans who rely on them.

"In 2011, we provided \$89,894 in charity care. In addition to this, we had an expense of \$230,019 related to uncollectible accounts. 


