

Hospital board hears report of new equipment that would help in lab

nfiala@nwkansas.com The Cheyenne county hospital board met in the basement of the clinic on Thursday, March 29. They first heard a diagnostic imaging report from manager Emily Rehmer. She reported that Darrell Reed, ultrasound and lab manager, wants to get a new table that would streamline the imaging process from what is set up now. She also mentioned the possibility of purchasing 3D imaging and bone density devices, but that a dexascan device would probably be more reasonable and possible for the hospital at this time.

Treasurer Jane Young wasn't present, but she had given her report to hospital administrator Les Lacy, who read the report.

Mr. Lacy gave his administrator's report, most notably stating that this board meeting had been rescheduled because he and Great Plains Health Alliance representative Jackie John had attended a financial meeting cleaning time at the Cheyenne in Washington D.C. at the time

scheduled. He said they had 30 minutes to make their case to receive additional funding and he said the representatives seemed impressed with what he had to say. Mrs. John also said that the measurable standards of GPHA should give reason for the politicians in Washington to take another look at their proposal.

Mr. Lacy also said that Deanna Grice is retiring and a new housekeeping manager would be sought out.



Problems in past years are still present and aren't simply just going to go away by ignoring them.




