in Oberlin, That's where Jeff Williams, formerly of St. Francis and a certified air and engine frame mechanic, and Glen Stragey did the wiring and ran the hydraulic lines

While all of the plane was being assembled, Linda was doing all the paperwork. There were forms for applications, registrations and certifications as well as photo albums detailing the progress.

Federal Aviation Administration inspections were made on March 7 declaring it "air worthy." Mr. Rogers first flew the new plane on April 1. The Federal Aviation Administration requires that the plane have 40 hours test flights before he can take any passengers

On April 5, he had flown over The Breaks putting on some test flight hours. When he was ready to land at the airport, the green lights that come on telling the pilot that the plane is ready to land, didn't come on. That, Mr. Rogers said, means the landing gear is not working.

If he couldn't get the gear to come down, he would probably have to land in the grass on the plane's belly.

I didn't want to do that, he said, because of the damage it would do to the plane. He pointed out that many people land safely without landing gears. However, he had just finished years of work on this plane.

Robert Grace, Richard Grace, Ron Schlittenhardt and Jeff Williams were on the ground talking with him. They were making suggestions to get the left gear down (the right gear was working fine).

I decided, he said, if this plane was going to be damaged, I was going to have some fun and, maybe, at the same time, bring that gear down. So he did some rolls. He also was jerking hard on the stick. The jar of the jerking and/ or the force of gravity brought the gear down, although, the green landing light was still not showing.

However, those on the ground assured him that both gears were down, so he made a trial landing but he didn't like the position he was in, so went back up and came down.

The landing was smooth. Emergency fire and medical service personnel were on hand in case they were needed and, they, along with everyone else, were glad to see a safe landing.

I really appreciated all the support, Mr. Rogers said. He also noted that he was glad he hadn't needed them.

When Mr. Rogers bought the plane kit, there were 25 T-51 Mustangs in the air. When he finished building his plane, his was the 51st. plane to fly in the USA. There are only 64 flying worldwide today.




