Rick Rogers, St. Francis, was present to find out more about the hospital board. The commissioners appoint members to the hospital board and with Jerry Toler retiring from the board, they were looking for a replacement.

He said that he is working with the Cheyenne County Development Corporation and donations made through the Corporation are tax deductible and will go to the non-profit organization.


Anytime we can help individuals who helped this nation is good, said Mr. Patton.


Mr. Carman said he will be generating community support and will be looking for grants.
