#### **Television** show host speaks on Monday

Dr. Jimmy Sites will be speaking at the First Christian Church in St. Francis on Monday, Jan. 28. There is a free dinner at 6 p.m. followed by Dr. Sites at 7 p.m.

Dr. Sites is the producer and host for the award-winning national television show, "Spiritual Outdoor Adventures." He will share his adventure stories from across the world.

Dr. Sites was in rural St. Francis at the Ringneck Country, Rex and Sandi Murray's lodge south of Wheeler, in November 2011. He and Ricky Skaggs, country-bluegrass singer, spent several days hunting pheasant and deer, while being filmed for one of his shows.

Dr. Sites' latest television production is the national award-winning television series Spiritual Outdoor Adventures. The program began airing in October 2002 and is now entering its ninth season, reaching 68 million households weekly across the country. Many celebrity guests appear on the program including Rascal Flatts lead singer Gary LeVox, Marty Roe of Diamond Rio, Contemporary Christian singer Michael W. Smith, coach Jeff Fisher of the Tennessee Titans, and numerous other professional athletes, movie stars, country singers, and well-known outdoorsmen and

Legendary outdoorsman Hank Parker has partnered with Jimmy on 13 episodes of show, and includes Jimmy as an occasional guest on his own hunting and fishing shows.

The mission of this weekly program is to spread God's Word the Bible – across the world. Over 110,000 Bibles have been distributed to viewers and listeners.

A new touchscreen console was installed in dispatch on Tuesday, Jan. 15. After a getting acquainted training period for the dispatchers, the new system was activated the following day.

Having worked with the new console for a short period time, the consensus of the dispatchers is that the system is well liked.

With the upgrade to the 800 system, dispatch and first responders will be able to communicate more effectively over a broader range.
