St. Francis senior Zach Gienger qualified for the 3-2-1A State Wrestling tournament by placing in the top four positions in his weight class. Zach earned a second place finish at 182 pounds. he is seeded third in the Kansas State Tournament and will wrestle Hunter Ackerman (30-10) of Douglass in his first match on Friday.

"This was by far the toughest regional in the state when it comes to 3-2-1A wrestling," said Dylan Loyd, coach. "We knew going into this tournament that if we wanted to qualify for the state tournament that we had to be on the top of our game. There were a lot of wrestlers from our regional that were returning state placers, or state qualifiers, that are staying home this upcoming weekend.
