Open burning means any outdoor fire, including, but not limited to, burning of trash, burning of fields, pasture, fence rows, any grass land or ditches, campfires, warming fires, charcoal grill fires, except this resolution shall not apply within the city limits of the City of Saint Francis or the City of Bird City. This resolution shall be in effect from the date of execution until such time as it is modified or rescinded by the Board of County Commissioners.

The Board of County Commissioners hereby declare that it shall be unlawful to violate this resolution and that any person found to be guilty of violating this resolution shall be subject to a fine not to exceed \$500.00 or confinement in the county jail not to exceed one month or
