# City council accepts bid for Emerson Street property

The council heard a bid for the East Emerson Street properties, appointed members to the pool board and the housing authority, as well as heard reports from the administration.

Only one bid was received to clean up the East Emerson Street properties. Brock McAtee offered to clean the lot, remove any existing structures and trees, and have it all completed by July 1. In exchange he said he would pay \$100 for each property, so \$200 total. Once the work is complete, he will receive the deed to the property.

City attorney Mike Day said they could put the deed in escrow until the work is completed. Upon completion, the deed would then be handed over to Mr. McAtee.

## Board accepts resignation

amiller@nwkansas.com The St. Francis School Board met on Thursday, Feb. 13. During the meeting, the board accepted one letter of resignation, discussed the upcoming open position for the next school year, and approved the 2014-2015 school calendar.

Judy Raile, the Elementary School At-Risk program director, submitted her letter of resignation to the school board. Rob Schiltz, superintendent, said that he was aware that she was planning to retire and she had told him at the beginning of the year. However, she will be missed.

"I really count on her a lot," Mr. Schiltz said.

Mrs. Raile's departure means that the At Risk position will be open. Mr. Schiltz said that he would ideally like to see the position filled by someone with training in kindergarten through grade 12. Currently Mrs. Raile holds the training to do kindergarten through sixth grade.

The At Risk Program is extremely important to have at the grade school, Mr. Schiltz explained. The primary role of the program is to help with reading school calendar.

The school board agreed to have Mr. Schiltz advertise for a kindergraden-grade 12 At Risk program director, and begin looking for one to replace Mrs. Raile next year.

Dr. Mary Beth Miller, board member, asked if there was anyone on staff that would like the position. Mr. Schiltz did not know that there was anyone with adequate training.

#### School calendar

The school calendar for 2014-2015 has been approved. The upcoming calendar year will have two less school days than this year's.

School is set to begin on Tuesday, Aug. 19. Christmas break will run Monday, Dec. 22 through Friday, Jan. 2.

Spring break will be the week of March 16 through 20.

The last day for seniors is May 13. Graduation is May 17, and the end of the school year will fall on Thursday, May 21.

These are just the main start and end dates. All the regu- ing will be held Thursday, lar holidays as well as parentteacher conferences and other days off can be seen on the school.

#### Other business

As well as discussing the opening for the At Risk position, Mr. Schiltz said now may be a good time to discuss personnel, if needed. By law, a school board must notify a teacher in writing on or before the third Friday in May if a teacher's contract will not be renewed. The board usually does contracts around April, said Mr. Schiltz.

After some discussion, the board agreed that they were happy with the new staff. No executive session was called.

Finally, Mr. Schiltz said that with all the snow, it has become evident that the two small tractors are not quite doing their job. He said it would be good to have something a little bigger.

Cody Busse, board president, suggested that Mr. Schiltz look into the pricing to trade something in. Mr. Schiltz thought it would probably cost around \$15,000, but he will look into it.
