# Judge orders treatment, supervision

Free Press Editor Michael A. Thompson, 18, of Colby,

was ordered by Thomas County District Judge Glenn D. Schiffner to be placed in an appropriate treatment program and further ordered that he be supervised by community corrections for a pe-

riod of 60 months

Thompson

for his part in a two-car collision, which resulted in the deaths of two other teenagers in January 2000. The decision was made during a sentencing hearing on Wednesday.

Thompson, who had pled guilty in April to amended charges of involuntary manslaughter and aggravated battery stemming from the deaths of Angela Duden and Justin Shaw, both 17 and both from Colby, was sentenced to 32 months on the manslaughter charge and eight months for the aggravated battery charge to run concurrently with the Kansas Department of Corrections.

However, based on sentencing

the decision was made to place Thompson in appropriate treatment and supervision, in lieu of a prison term.

Prior to Schiffner's ruling, victim impact statements were made from members of Angela Duden's family to include her mother, Doris; father, Ivan; and sister, Sarah, along with testimony from the defense, which included a neuro-psychologist at the Craig Rehabilitation Center in Denver and Thompson's mother, Christina.

In addition to those who spoke at the sentencing hearing, Judge Schiffner said he had also received many written statements as well.

The accident happened on Jan. 29, 2000 at the intersection of Thomas County Road 27 and Highway 24. Thompson was driving a 1976 Cadillac and Duden was driving a 1995 Probe. The crash occurred when Thompson failed to stop at the intersection.

Shaw was a passenger in Thompson's car and Brice Reynolds and William Pederson of Colby were passengers in Duden's vehicle.

Shaw was pronounced dead at the scene and Duden later died in Denver. Both Thompson and Pederson suffered major head trauma and were hospitalized and in rehabilitation for almost a guidelines and testimony presented, year after the accident.

Stovall, 45, said she'll marry Larry Steckline, 60, over Labor Day weekend, The Wichita Eagle reported in today's editions. The Aug. 31 wedding will be in St. Elizabeth Catholic Church in Grand Lake,

Stovall, who is president of the National Association of Attorneys General, introduced Steckline to the staff in Attorney General John Ashcroft's office and divulged their plans.
