#### **Ryan Hale**



**Dear Kansas Consumer:** 

My office cannot tell consumers whether a particular multi-level marketing plan is legal or give advice as to whether or not to join. However, the following are some tips for consumers to consider when deciding whether or not to join a particular plan:

Avoid any plan that places emphasis on recruiting additional distribu-

 Beware of plans that ask new distributors to purchase expensive inventory.

· Beware of plans that claim to sell miracle products or promise enormous earnings. Ask the promoter of the plan to substantiate claims with hard evidence.

· Beware of decoy references, also known as "shills," who are paid by a plan's promoter to describe their fictional successes.

 Don't pay or sign any contracts in an "opportunity meeting" or any other high-pressure situation. Insist on taking your time to think over a decision to join.

· Some plans sell items at astronomical costs (i.e. \$1 coins for \$25 each). This is a red flag that should raise questions as to the quality of the organization.

• Avoid plans that receive a greater percentage of income from recruiting new members or people in a "downline" or "circle" than from product or service sales.

Check with my office and the Better Business Bureau to see if complaints have been filed against the plan you are considering. You may call my Consumer Protection Division at 1-800-432-2310.
