Illegal dumping won't be tolerated, county warns

The Thomas County Commissioners are not tolerant of illegal dumping and will be vigilant in their quest to catch the culprits, said Commissioner Glen Kersenbrock at their Monday meeting at the courthouse.

Larry Jumper, landfill supervisor, reported that several people had dumped trash in the ditches, and some in the road near the landfill. He said the sheriff's deputies caught a couple of people who were dumping, and notified them they could either pick it up, or be prosecuted.

Jumper said the landfill was averaging about 15 tons per day of municipal solid waste, well under the 20 tons allowed to keep the landfill open.

He said contamination at the monitoring well at the landfill was improving. It has gone from .0041 to .00341. The contamination is believed to be solvents but is well within tolerance,

The landfill could be closed if the count were too high; however, the county is closing the contaminated pit, and will be opening another pit within the year. Contents of the new pit will be carefully monitored to prevent contamination, Jumper said.

Jumper said he was looking at a used road grader which belongs to the city of McDonald, which he hopes to buy to use at the landfill. The landfill has been borrowing a road grader from Colby, but "we can't count on borrowing the city's grader," said Commission Chair Ron Evans.

Jumper said from Jan. 1 to May 31, the landfill received and processed: 294 appliances; 840 loads of construction and demolition material (795 tons); 131 loads of concrete (487 tons); 828 loads of metal (213 tons); 2,947 loads of municipal solid waste (2,232 tons); 1,560 gallons of used oil; 366 used tires; 1,719 loads of trees (421 tons); 576 loads of yard waste (204 tons); 36 loads of grain (96 tons); and 24 loads of grain dust (56 tons).

The landfill gave away 91 tons of compost, Jumper said. Total waste processed at the landfill was 4,820 tons,

Probation handed down in indecent liberties case

Free Press Editor A Colby woman was sentenced in Thomas County District Court last week to 36 months probation on two felony-level charges of indecent liberties with a child under the age of

Tonya S. Meyer, 25, was originally charged with statutory rape in April of 2001, but in early April of this year, she entered into a plea negotiation and subsequently pled guilty to attempted aggravated indecent liberties with a minor and aggravated indecent solicitation of a child.

As part of that agreement, the rape charge was dismissed and the second been aggravated indecent liberties with a child, was amended to "attempted" aggravated indecent liber-

At the sentencing, Thomas County Attorney Allan Taylor told District Judge Glenn Schiffner that prompted by Meyer's acts, the victim's childhood had been taken away. In addition to probation, Schiffner ordered that Meyer regisblood and saliva samples to the Kan- the solicitation charge.

sas Bureau of Investigation to be kept on file with the KBI. He also said that should she be refused into the sex offender program, she could be ordered to serve 32 months with community corrections.

She is also required to stay away from the victim or any child under the age of 18. Schiffner also ordered that Meyer pay \$400 restitution to the victim plus costs that might arise later for counseling.

The victim told the court how Meyer had committed sexual acts with him since he was 11 years old and that these events continued until he was 13.

The charges stemmed back in count of the indictment, which had May of 2001 when Meyer was arrested after authorities were alerted of allegations that she had been involved with a young child, who is now 14. At that time, the complaint alleged that Meyer had engaged in lewd touching and that she allegedly had accosted him into committing unlawful sexual acts. Prior to sentencing, Meyer could have faced 50 to 136 months in jail for the attempted aggravated indecent liberter as a sex offender and submit ties charge and 32 to 46 months for
