

tion of the problem over the last 10 or more years has not all been while Hillary has been ill.

Both the commissioners and the sheriff say in the past efforts have been made to clean up the mess, but it continues to come back.

Citizens are concerned not only in the appearance of the property, but also the health, safety and fire issues it raises.

Collett, whose family lives near Hillary, also said when her children were young she was very concerned about the fact that things living in the area (skunks, snakes, rats, etc.) would jeopardize her children's safety.

McKiski said he and other residents are tired of hearing that Levant "used to be" a great community to live in. Many of those who own homes in the community would like to see it grow, prosper, and once again thrive.

"In five or ten years for this town to survive, it has to be clean," said McKiski.

One big complaint of the citizens is the fact the laws and statutes which apply elsewhere are not being enforced in their community.

McKiski said many farmers in the area have had crops mowed down when they plant too far into the ditches, since they are in the county right-of-way.

Most do not disagree with the practice, but they want the property of Hillary to have the same repercussion as theirs.

Attorneys from outside the county have advised the citizens of laws to handle these kinds of situations that are in place, and that Hillary is breaking

many of them. The next step would be to enforce the law, and that is where the process begins to fall apart, said Collett.

Some of the laws Hillary is allegedly breaking would be: trespassing on railroad property, maintaining and permitting a public nuisance, abatement of nuisances, failure to remove a public nuisance, unlawful obstructions of a roadway, abandoning and leaving vehicles on a highway, violations of road laws within a township, littering, as well as others.

Rosalie Seemann, a resident of Levant for more than 44 years, said, "People should take pride in what they own, and should stop blaming what has happened to our community on losing the school."

McKiski reminds citizens of Levant and other small communities to stand up for what they know is right. "Those who care about what goes on in their towns should contact their commissioners, the sheriff, and others who control the places they live."

People should be aware there are several different right-of-way widths throughout the county and to be sure they are in compliance with the county laws, they need to check with the Thomas County Road Department, Engel said.
