# Judge dismisses restraining order against doctor

A lawsuit involving a restraining order filed in Thomas County District Court initiated because of allegations of misconduct on the part of a local physician by an employee at Citizens Medical Center, Inc., was dismissed

granted the dismissal after hearing from Ronald Vignery, attorney for the hospital, and Ronald Shalz, attorney for Dr. Victor Hildyard, in what was a joint agreement by both parties on the

Although the restraining order has been completely lifted and is no longer a court matter, Carol Bonebrake, Topeka, the attorney for Citizens Medical Center said, the issues stemming from the initial restraining order still exist. There will eventually be a hearing in front of the hospital's board of trustees regarding the allegations made by the hospital employee and Dr. Hildyard will be entitled to know the outcome, she said.

Since the initial complaint, Hildyard said this week, he has no idea what the allegations are or what the outcome of the investigation was. However, Vern Schwanke, president of the board, did say earlier this month that the independent investigator's review was completed and forwarded to the board members.

Bonebrake agreed that Hildyard has not been made aware of the allegations either.

"It is not a public matter," she said. "A complaint by an employee is a confidential and personal document and subject to a confidential investigation.

> Yet Bonebrake did say earlier this week that there's always the opportunity for the "oppressed" to talk about it, but in this case, hospital officials and board members are not at liberty to discuss anything regarding the situation again because of confidentiality.

In the transcript from the proceedings from Thursday, May 2, Shalz told Judge Burr that subject to the court's approval, the hospital and Hildyard had agreed on an order that would lift the restraining order put in place on Friday, April 26 and allow him to immediately begin practicing medicine and seeing his patients at the facility.

"We reached this agreement," Shalz said on May 2, "primarily as a result of some occurrences that happened after Friday (when the restraining order was

"Part of the agreement," he said, "is that I would be allowed to announce in open court that what everyone has seen, that this complaint that basically started all of this by a hospital employee, has been rescinded by that employee.'

Shalz added that the employee is District Court Judge Jack Burr further unavailable to testify as a wit-

> "We have filed on behalf of Dr. Hildyard a request for an immediate hearing (May 2) with the governing board of the hospital and Mr. Vignery told me that they are going to accommodate us on that request," he said.

> While both attorneys agreed to the restraining order being dismissed, there were many differences as to how something like this could surface in the first place.

"When a serious statement was presented to Mr. (Michael) Boyles (chief executive officer at the hospital), he reacted, received advice about it, gathered the facts and information that he had available to him at the time and made a decision that he was allowed to make according to the policy," Vignery said.

"Mr. Shalz, of course, disagrees with that, but that's the position that was taken and that's why the restraining order was sought," he said.

Shalz said on May 2 at the proceedings that summary suspension was imposed unilaterally by Boyles. "I don't believe the board of trustees had any involvement; in fact, I don't think they knew about it until a few days after the summary suspension was imposed," Shalz said.

Hildyard's attorney said that the reason they were in court on the restrainhospital. In a press release earlier this week from the hospital's attorney, Bonebrake said that while the lawsuit is no longer needed, the hospital and Hildyard have not only agreed that he would abide by the policy in place, but also that they agreed the matter was subject to further review.

The reason for further investigation, Vignery said at the May 2 hearing was that even though the hospital was willing to back off on the summary suspension because of the information received that the witness had rescinded statements, it didn't mean that the board of trustees wouldn't continue with an investigation.

Following the recent decision to dismiss the lawsuit on the restraining order and suspension, no other public information has been made available.
