Investigation surrounding chase continues

Colby Free Press The investigation continues into the high speed chase which occurred in Thomas and Logan counties on Sunday night, and it's connections to the death of a Grand Junction, Colo. man. Gary Shull, Colby Police Depart-

ment investigator, said Monday afternoon that an investigator from Mesa County, Colo. flew into Colby to assist in the investigation, and it has been determined that the 1991 Mercury Topez seized at the crime scene in Logan County is the vehicle that was apparently stolen from the man who was shot and killed in Mesa County.

Shull said investigators from the Kansas Bureau of Investigation, Mesa County Sheriff's Department, Thomas County Sheriff's Department, Kansas Highway Patrol and the Colby Police Department processed the car all day Tuesday until 8:30 p.m. He said the processing included collecting property and photos of the vehicle as well as items to be processed for latent prints, items processed for DNA traces, bullet fragments and other documents.

Today, plans are to continue the investigation and process the undercarriage of the vehicle. According to

Shull, this would include collection of vegetation, soil, tire impressions and measurements.

The two arrested on scene Sunday night were identified as Melissa Ricketts, 20, of Helper, Utah, and Ryan Schneck, 26, of Provo, Utah. They are still being held in the Thomas County Jail.

Shull said the Thomas County Sheriff's Office has recommended to Thomas County Attorney Allen Taylor that Schneck and Ricketts be charged with aggravated assault on a law enforcement officer, criminal discharge of a firearm, and possession of stolen property.

Shull said that Logan County Sheriff's Office is expected to file charges today on Schneck and Ricketts.

The third suspect involved with Schneck and Ricketts was Robert Todd Poulsen, age 30, of American Fork, Utah. According to authorities he was taken to the Logan County Hospital in Oakley on Sunday night where he was pronounced dead after a fatal gunshot wound, believed to be self-inflicted.
