You are hereby notified that the Plaintiff's Attorney has chosen to initially proceed with this matter administratively and is making stipulation of exemptions available for the property seized for forfeiture as described above.

You may do any of the following:

(1) File a verified petition for Request for Stipulation of Exemption with the Plaintiff's Attorney **and** sending a copy to the Seizing Agency; or

(2) File a verified claim with the Court, sending copies to the Plaintiff's Attorney **and** the Seizing Agency; or

(3) Do nothing.
