# **District's books** in good shape; building mulled

Colby Free Press Brian Staats, with the firm of Adams, Brown, Beran and Ball, told the Colby School board Monday night that the financial audit the firm was asked to do found no material irregularities, and no budget violations for the 2001-2002 school year.

"We found no reportable conditions," Staats told the board. Staats also praised the school district staff for its help in the audit, telling the board he appreciated the professional way they helped whenever the auditors had a question.

"We just wanted to let you know that you have a very good staff here," he told the board. Later in the meeting, the board approved the acceptance of the

# Advanced voting now underway in county

### **Ballots available at courthouse**

Advanced voting is underway for the Nov. 5 general election, Tracey Perkins, Thomas County Clerk/Election Officer, said in conversation Monday afternoon.

"Yes, ballots can now be picked up at my office," she said.

Those taking advantage of advanced voting — they used to use the term 'absentee ballots' — have until noon on Monday, Nov. 4 to secure a ballot.

They then have to be returned to the clerk's office by the time polls close at 7 p.m. on election day.

Perkins said the sick, disabled, or those in the hospital, can get an advanced voting ballot up election day,

but the ballot still must be in the hands of the county clerk's office by the time polls close.

Questions can be directed to Perkins or her staff at 462-4500.

The spirited campaign for governor is expected to boost the number of voters statewide.

The race involves Insurance Commissioner Kathleen Sebelius and State Treasurer Tim Shallenburger. Sebelius is a Democrat and Shallenburger a Republican.

There are also two other candidates in that race — Ted Pettibone, Reform Party, and Dennis Hawver, a Libertarian
