Nothing herein shall prevent or limit the City Attorney from conducting his private practice or prevent the City of Colby from obtaining other counsel to represent it on specific matters or cases not included under the duties of the City Attorney

SECTION 6. REPEALER. Ordinance No. 1326, dated December 18, 2001, is hereby repealed.

SECTION 7. This Ordinance shall be in full force and effect from and after its publication in the official city paper as provided by law.
