Colby Free Press Seven proposals for a new Wellness Center/Fitness Lab for Colby Community College were unveiled Tuesday night by Dr. Mikel Ary, college president, at the college's board of trustees meeting. The seven proposals, out of 16 requests which were sent out by Dr. Ary, came from architecture firms from a wide area, including Colby, Hill City, Hays, Denver and Wichita.

"It's been five or six years since we've addressed the infrastructure of the campus," Ary told the board. "With this new facility, we have a chance to have a better linkage with

In other business, the board:

• Approved a contract for Tricia Reichert, anatomy and physiology, "Coach Lampe's input was through EduKan, and hired Nick

Wells to run the Endowment Association. Wells' contract will be paid on a 75/25 percent split, with Endowment paying 75 percent of his salary, and the college paying the other 25 percent.

• The board approved agreements for Physical Therapy Assistant affiliations, and also agreed to a 48month contract for the maintenance of the college's phone system, at \$1,073 dollars per month.

This represents a savings of nearly \$500 per month under the old contract for phone maintenance.

• Dorm rates are being raised 3.2 percent, to reflect the rise in the Consumer Price Index. Room rates will stay the same this year, \$1,802 dollars for 9 months, but meal plans are going up to \$45 dollars, for the 14-meal plan, and to \$48 for the 19meal plan.
